A Special Meeting of the Board of Education, Seaford Union Free School District, was held on Thursday, May 9, 2013, in the Auditorium of Seaford High School, 1575 Seamans Neck Road, Seaford, New York.

At 7:40 p.m., the President of the Board of Education opened the Special Meeting. As the first order of business, Board President Brian Fagan led the audience in the Pledge of Allegiance.

OPEN SPECIAL MEETING

Superintendent Brian Conboy opened by speaking about Seaford High School's FIRST Robotics Team, the brief history of the team, building of their robot, events/efforts which took place prior to their trip to St. Louis and their competing in the National First Robotics Competition in St. Louis, Missouri.

Members of the Seaford High School Robotics Team introduced themselves and gave a demonstration of the capabilities of their robot. The team thanked the Board, Administration and Community for their support, contributions and for making this team a reality. The students presented a First Team logo signed by all the members of the Robotics Club to Superintendent Brian Conboy.

Board President Brian Fagan introduced the members of the District's Audit Committee and spoke about their backgrounds, credentials and expertise. He expressed his appreciation for their work on behalf of the District and their role on the Committee. Nicholas DiMola, Audit Committee Chairperson explained that an RFP had been issued for external auditing services. He briefly explained the process. After a review of the proposals received the Audit Committee is recommending R.S. Abrams to continue providing those services. He also spoke about provisions of the contract including the reduction of fees for the 2013/2014 school year.

Mr. DiMola also advised that the Audit Committee would like to meet with the Board to go over areas for the Audit Committee work plan and Cristina Spinelli's internal audit work plan.
