PUBLIC COMMENTS

- Was there a recommendation/written documentation from the Budget Advisory Committee given to the Board Board had previously told the PTA Presidents that they should have submitted their requests to the Budget Advisory Committee; that the Committee would be making recommendations to the Board Concerns over cuts to Middle School
- Methods used/items included when creating budget versions
 Not happy with 3.59%; why didn't you try to go lower
- District needs to look again at the teachers counter-offer
- Concern over cuts that will devastate our schools and children; loss of exploratories, advisory, literacy workshop and foreign language Middle School cuts will have a ripple effect Need to work together
- Education is for the students
 - Need more communication between the Board, Administration, Teachers and Students; need to speak more with the students about their education
- Concerns over possibility of AP classes being cut

Members of the Seaford High School Robotics Club thanked the Board, Administration and community for their support. They advised that they had received the Rookie All-Star Award at the First Robotics Competition which gave them a bid for the National Robotics Competition in St. Louis, Missouri. The cost of entry was \$5,000 which the Club was able to raise. They explained how that they were going to see if First Robotics would grant them an extension to submit their money but first they needed to get Board approval to send in the \$5,000 check. They explained that 16 students would be going along with 2 teachers and a security guard, how they would get to the completion and back and the cost of transportation/hotels/meals (\$550.00 per student). This amount does not include the costs for the two teachers or the security guard. They also advised that the bus cost would be split with Great Neck South. The bus would be leaving on Tuesday, April 23rd and returning to Seaford on Sunday, April 28. The families of the students will pay the \$550 per student to pay for their hotel, meals and bus. Students were asking the District to cover the cost of the Security Guard, 2 teachers and hotel rooms/meals for security, teacher and bus driver.

United Teachers of Seaford stated that they would pay the costs for the 2 teachers.
