Going forward we will be trying to keep 2 distinct types of Board Meetings each month

- Regular meeting with voting on personnel items, etc.
- Workshop meetings to discuss various topics
- Tonight's topic is Board goals for the 2014/2015 school year

Will need an executive session this evening

Items requiring Board approval on this evening's agenda

- Resolution concerning paperwork still needing to be signed related to the Seaford Avenue School for the Nassau County Planning Commission
- BOCES Technology contract related to white boards/projectors
- Resolution related to Middle School Summer School and revision of Board policy

Guidance related to tax cap going forward and eligibility for the 1% tax cap savings related to additional efficiencies

- Encouraging districts to work with their local BOCES
- Have until June of 2015 to establish what our efficiencies will be related to that

Update on Harbor Roadway IMA language

 Will forward any questions the Board may have to Antonia Hamblin at Ingerman, Smith

Mr. Kahn asked about the timeline for the IMA

Mr. Kahn advised that Legislator David Denenberg offered any help he could give in moving this forward

- Mr. Kahn stated that we need to make sure it gets done

Mr. Kahn also advised that a correction needed to be made to the last paragraph of Agenda Item B.1. changing 2014/2014 to 2014/2015.

None PUBLIC COMMENTS

Areas covered in the discussion:

Mr. Conboy advised that we will not be able to determine the success of last year's goal relating to student assessment performance (the 22 data points) until the end of summer when the data related to that will be available

Ms. Ruona brought the sheets from last year explaining that some of them could be continuing goals

The three goals from last year were:

- Board of Ed/School District Administration Communication
- Student Performance
- Budget/Budget Timeline

Discussion continued on possible goals for the new school year including:

- 3-year Plan for restitution of program
- Set priorities for restoration of programs over the next 3 to 5 years
- Need to make a list of what was cut and recommendations from Superintendent as to order of restoration
- Goal discussion to continue at August Workshop meeting
- Ms. Ruona and Ms. Wink will meet with Mr. Conboy prior to that meeting
- Find different sources of incoming revenue

Mr. Conboy also advised that if we are going to have distinct workshop meetings going forward we should set the topics for discussion. Discussion concerning the topics and the best meeting for each topic to take place continued. It was suggested that the following would be discussed at Board Workshops during the 2014/2015 school year:

- November Veterans' Exemption & Board Policies

January ACT/BudgetFebruary – April Budget

In response to Mr. Kahn's request, Ms. Stark volunteered to review the Board Policies. Ms. Ruona advised that if Ms. Wink cannot do it then Ms. Ruona or Mr. Kahn would.

- Presentations last year on the Common Core
- More information we can get out to parents the better it will be; get the facts out to them
- Possible ways to get information to parents
- Go Math Night for parents this year
- APPR/Common Core/State Testing being all mashed up into one
- Creation of a document with all the facts listed
- What students who are not taking the test will do during the testing time
- Concerns over what kind of stop-gap solution the State will implement
- New York State can withhold aid from the District

BE IT FURTHER RESOLVED that, in accordance with the contract between the Seaford School District and B.K at Seaford, the Board President is authorized to execute any additional applications and related documents needed in connection with the approval process with the Town of Hempstead associated with the Seaford Avenue School property.

WHEREAS, strict adherence to the above regulation for affected students pertaining to the summer of 2014 is impractical given the shortage of summer school programs in the area;

NOW THEREFORE, be it resolved that Administrative Regulation 4750-R is hereby suspended for the summer of 2014 for the reasons reflected herein; and

BE IT FURTHER RESOLVED, that administration is directed to implement appropriate alternative criteria for promotion in middle school for the 2014/2015 school year.
