Need for exec session to discuss some negotiations with some of our bargaining units and a specific student issue and a personnel issue.

WORKSHOP TOPIC: BUILDINGS/CONDITIONS

Building Condition Survey should be done every five years

- We are at end of one done in 2011; next one will be in October 2015
- Walk through of all four buildings; two done so far

Remaining capital project

Many projects named in the five-year plan were done as part of the bond capital project

Possible projects in each of the buildings and district-wide

- Items listed from 2011 survey as well as new items which now need work
- Manor School
 - Entry way at Central Administration
 - Interior doors in B and C Wings
- Harbor School
 - Walk-through not done yet
 - Harbor boilers also expensive item
 - Exterior lighting
- Gym floors not bad; Stage floors in worse condition
- Kitchens
- Unit ventilator replacement

- Middle School
 - 2nd floor interior door replacement
 - Exterior lighting
- High School
 - Library carpet
 - Unit ventilator replacement
- Grounds
 - Fencing
 - Varsity baseball field

Board/Administration questions/discussion:

List just continually gets longer; ongoing

- Using last remaining bond money to remediate issue at Middle School
- Long-term planning; need to be very careful how we are planning repairs and capital projects going forward
- Bond was passed in 2007

Mr. Kahn and Ms. Stark did tours of Manor School and Middle School

No major issues but noticed a few things needing replacement/attention:

- Ceiling tiles
- Minor painting
- Cracked window pane at Middle School

Discussion on repair reserve:

- Repair reserve is very specific; outline maintenance and repairs; depends on how the fund was set up and what you want to do
 - Repair not replacement
- What is aidable
- Get parameters for Board from attorneys to determine what fund can be used for – will render Board an opinion
- Proposition in May 2014 to create a Repair Reserve Fund
- Leeway in repair reserve fund
- Use money from sale; not cost taxpayers anything
- Resolution language is very specific;
- Lag time between getting state aid back for project
- How much would we need in cash
- What constitutes repairs; what constitutes a capital project
 - How much money we will need for repairs; how much for capital projects
- Requirements for setting up capital reserve fund; must be specific and must be voter approved

Mr. Conboy advised that this summer we hired a new Maintainer and a new Groundskeeper
