WORKSHOP DISCUSSION SMART SCHOOLS BOND ACT OF 2014

Areas covered in the Power Point presentation/discussion concerning the Smart Schools Bond Act of 2014:

- Great diversity in New York State
- New York planning a completely computer-based testing program
- Passed in the 2014-15 Enacted Budget and approved by the voters in a statewide referendum.
- The Smart Schools Bond Act (SSBA) authorized the issuance of \$2 billion of general obligation bonds.
- The money will be used to finance improved educational technology and infrastructure to improve learning and opportunity for students throughout the state.

Four Eligible Uses

- 1. Acquire learning technology equipment or facilities.
- Install high-speed broadband or wireless internet connectivity for schools and communities
- Capital work for pre-kindergarten programs and replacement of modular classrooms.
- Install high-tech security features in school buildings and on school campuses

Allocation Amount

- Eligible school districts are those that receive Foundation Aid.
- The allocation amount is proportionate to the District's share of total formula based school aid in the 2013-14 school year.
- Seaford School District allocation is \$1,103,841.

Instructional Technology Plan Survey (already approved by State Ed)

- Necessary for Smart School technology purchases.
- Must be submitted to NYSED by October 16, 2015.
- Our District Plan Survey was submitted on October 2, 2015 and approved on October 5, 2015.

SMART SCHOOLS BOND (cont'd)

Smart Schools Improvement Plan

- All districts must develop and receive approval of a Smart Schools Improvement Plan from the Smart Schools Review Board.
- Plans will describe the intended expenditures and projects.
- There are no deadlines for submission of the Plans as these funds do not expire.

Required Elements of the Plan

- Demonstration of Need
- Describe strategic approach to understanding and meeting students' needs while aligning to current plans in place.
- Adequate Technological Infrastructure
- Demonstrate infrastructure of 100 Mbps per 1,000 students currently exists in buildings where new devices will be deployed (*precondition).
- Professional Development
- Describe plan to ensure deployment of technology to enhance instruction will be successful. Must contact SUNY teacher-prep program for advice. SSBA funds may not be used to support PD.
- Technical Support
- Provide on-going support for preparation, distribution and maintenance. SSBA funds may not be used for support.
- Sustainability
- Demonstrate long-term plan to physically maintain investments. Capacity to support recurring costs (maintenance, replacement, tech support, Internet fees, etc.).

Application Process for Seaford

- District develops preliminary plan to spend \$1,103,841.
 - Nassau BOCES has provided the District with a Network Infrastructure Analysis.
- Stakeholder Engagement: consultation with parents, teachers, students, community members, nonpublic schools and other stakeholders must take place. DWST & ACT Committees to meet.
- Board of Education (BOE) will review the preliminary plan.
- Draft plan will be posted on District website for 30 days.
- BOE will conduct a public hearing enabling stakeholders to respond to the plan.
- District will prepare final plan for BOE approval.
- BOE-approved plan will be posted and uploaded to NYSED portal for submission.

Suggested Uses for Seaford

- Cabling
- Switches
- Wireless points
- Intercoms/Monitors/Cameras

Other areas covered in the discussion included enrollment, current infrastructure compared to State requirements, bandwidth, SEC recommendations, BOCES, equipment for private schools, how to get stakeholders' input, ACT Committee, District Wide Safety Committee, notifications, State Survey – three-year plan, district five-year plan, school notification system (Shout Point) and district website alert system (put blurb in District Newsletter informing public how to register).
