BE IT RESOLVED, that the Nassau BOCES Proposed Administrative Operations Budget for the 2018-2019 school year in the amount of twenty-one million, nine hundred sixty-two thousand, six hundred fifty-two dollars (\$21,962,652) be, and hereby is, approved by this Board.

RESOLVED, based upon a recommendation from the Superintendent of Schools, that the Seaford School District budget for the 2018-2019 school year be approved by this Board of Education and presented to the community for voting purposes under Proposition #1 on May 15, 2018 in the amount of \$68,436,438, with a budget-to-budget increase of 2.62% and a tax levy increase of 2.69%.

BE IT RESOLVED, that the Board of Education of the Seaford Union Free School District hereby authorizes the following proposition to be placed on the ballot of the May 15, 2018 annual vote:

SHALL the Board of Education, pursuant to Education Law section 3651, be authorized to establish a Capital Reserve Fund known as the "General Capital Reserve Fund" for the purpose of performing the following capital improvements: instructional and non-instructional space improvements/renovations/upgrades, including but not limited to classroom improvements/renovations/ upgrades and/or additions to existing facilities, auditorium renovations, gymnasium renovations, cafeteria renovations, library/multi media center renovations, exterior renovations/ reconstruction, computer/technology upgrades, security system upgrades, plumbing improvements/ renovations/ upgrades, electrical improvements/renovations/ upgrades, HVAC improvements/renovations/upgrades, energy efficiency improvements/ renovation/upgrades, including the installation of solar power, improvements/ renovations/ upgrades, renovations required for compliance with ADA requirements, vocational and career preparation renovations, portable classroom replacement and/or purchase, roof/gutter/leader replacement, window replacement, masonry/concrete replacement, interior and exterior door/entry ways replacement, toilet room renovations, lighting upgrades, floor replacement, wall replacement, boiler replacements, elevators, carpentry renovations, purchase of buildings/ land, site reconstruction, box/dugout/field press improvements/renovations/upgrades, improvements/renovations/upgrades, upgrades of signs, athletic field renovations/reconstruction, playground renovations, lockers/locker room renovations, public address/clock system replacement, sound system upgrades, telephone system upgrades, hazardous material remediation, storage space renovations, furnishings and equipment, including the purchase of vehicles, all of the foregoing to include all labor, materials, equipment, apparatus and incidental cost related thereto.

The maximum amount of the aforesaid Capital Reserve Fund shall be \$20,000,000, plus investment income. The probable term is to be 10 years; the funds are to be transferred from surplus monies, if any, remaining in the general fund including a sum not to exceed \$2,000,000 from the 2017-2018 budget and thereafter in an annual amount of not more than \$2,000,000 for each remaining year of the probable term. Upon the establishment and funding of said reserve, the Superintendent of Schools or his/her designee shall be directed to deposit monies of this reserve fund in a separate bank account to be known as the "General Capital Reserve Fund."

Board President Bruce Kahn stated the following:

The Board of Education and Administration have been discussing the community concerns regarding armed security guards.

The Board will be establishing an Advisory Committee for the purpose of researching security staffing in schools.

- Committee will be comprised of various stakeholders in the community, including approximately 3-4 resident parents. Over the next few weeks, we will be developing the application process for these positions. Information will be posted on the website.
- Application process for this committee will be developed over the next few weeks and then information will be posted on the website
- Committee will be similar to committee created several years ago to explore policies and procedures regarding anaphylaxis which was an effective structure for researching and discussing best practices related to that topic
- The Security Guard Staffing Advisory Committee will make recommendations to the Board of Education that are driven by evidencebased research.

Mr. Kahn advised that after Mr. Flynn's presentation there would be an opportunity for resident's comments. He asked that anyone wishing to ask a question please fill out an index card and the Board/Administration will try to answer them. He also advised that any questions identifying safety in the schools may not be answered.

CLOSING REMARKS

Closing remarks by the Administration and Board

Mr. Rail advised that back in October 2016 the District hosted a Narcan program at Seaford High School. All our nurses are training in Narcan

Mr. Kahn advised that we have one seat open on the Board for this year's vote. Mr. Rail's seat is up. There are two candidates running for that seat: Patrick Rail and Andrea Parisi. He also advised that anyone interested in registering to vote should contact the District Clerk at 592-4003.

Thank you to Mr. Flynn for his presentation

Board Trustee Patrick Rail stated that when he became a Board member in 2015 he began to understand how important the health, safety, security and well-being of the students and staff was to the administration and the Board. Whatever the topic, safety and security were always part of the conversation. After the shooting incident in Parkland, FL the administration and Board of Education decided to take a hard look at our school security plan to see if any changes were necessary to increase the security in our district. He went on to

MR. RAIL (cont'd)

Over the last two months the Board and Administration have done the following:

- Reviewed and discussed the District's security Plan
- Hired an independent security consultant to review our District
- Reached out to Law Enforcement for information and Advice
- Partnered with Nassau county Police Department to acquire the Rave app and to allow access to the district's camera feed.
- Inquired with neighboring districts what security practices they use.
- Listened to community's comments and concerns.
- Our Superintendent spearheaded this project listening to all the stakeholders and security experts and then using that information to develop a plan, and then executing that plan.

Another component to our district's security is the social, emotional, and mental health of our students.

- Security staff does an excellent job, but safety doesn't end there.
- District has an incredible staff of more than 500 employees who further safeguard our students

Our community plays an important role in the security of our schools and our more than 2200 students play a key role in our security.

- Our students are taught if you see something say something.
- This has been used countless times with much success in all our schools. The District will now have the new Anonymous Alerts System on our school website.

Mr. Rail spoke about social media. He clarified that information appearing in social media stating that the Board is not listening to the community is false.

He went on to say that information on social media is not always accurate and sometimes false. He asked that if the community wanted facts please contact the district and your questions will be answered.

Mr. Rail closed by thanking Ms. Pellati and her staff for all their hard work in preparing the 2018-19 budget, and for also making the necessary adjustments to the budget so we are able to improve the district's security.

He also thanked Mr. Striffolino and Dr. Pecora for getting the staff on board with the new security enhancements and for all their work on behalf of the students and District.

Mr. Kahn advised that the safety of the students comes first but there is a process that needs to be followed to put things in place

Dr. Pecora stated that when we look at the safety of children we cannot look at it just in the vacuum of just infrastructure. We have to talk about when they walk into a building do they feel safe; do they have a good experience and are they in a good environment where they can learn and learn well.

Reminder about the upcoming parent meetings

At 8:22 p.m., a motion was made by Ms. Stark, second by Mr. Rail, to adjourn the Special Meeting and enter into Executive Session for the purpose of discussing 1 specific student issue, 2 specific personnel issues, a matter concerning the safety of the District and a proposal for legal counsel.
