

A Special Meeting of the Board of Education, Seaford Union Free School District, was held on Tuesday, December 8, 2020, via Zoom, and live streamed in Seaford, New York.

At 7:02 p.m., the President of the Board of Education opened the Special Meeting. As the first order of business, Board President Bruce Kahn led the audience in the Pledge of Allegiance.

Mr. Kahn advised that this was a one-item meeting. He then asked Dr. Adele Pecora to speak a little about the contract on the Board agenda.

Dr. Pecora briefly explained the purpose of entering into this contract. Areas she covered included:

COVID guidelines related to testing
Yellow/Orange/ Red Zones
Testing requirements/timelines for each Zone
Massapequa School District's experience with the requirements and testing with this company
Need to be prepared
Understanding from community is preference to have schools remain open

Ms. Parisi confirmed with Dr. Pecora that parents could accompany their child to the testing site. She also asked about notice for when the testing will take place and the location for testing and when testing could be stopped.

Dr. Pecora advised that testing will be voluntary, and it is 20% of the entire population per school (students and staff) and the District will have a list of those willing to be tested. Dr. Pecora stated that the testing site would probably be handled similar to voting and that space would be thoroughly sanitized before students would be let into that room.

Mr. Kahn asked that if once we run through all the volunteers is it no longer voluntary. Dr. Pecora advised that the Board and Administration would need to then make a decision as to the best way to move forward – going remote/in-school learning, etc. She also clarified the requirements as they exist now, for stopping testing.

Motion by Mr. Devlin, second by Ms. Parisi, to approve a testing and screening services agreement with ATC Testing and Screening Services, LLC for the 2020-2021 school year and authorize the Board President to sign said agreement.
