Mr. Kahn advised that the annual Budget Hearing will be held on Wednesday, May 5th in the High School Auditorium

In response to Mr. Kahn's question related to monies available for Universal Pre-K, Dr. Pecora explained that even though it is State Aid, it is considered a grant for purposes of budgeting. It is not in our budget - similar to the Federal funds. Our District does not have the space to run Pre-K in house. It is also only for a limited time that they are guaranteeing the funds (right now two years). We would have to send out proposals to some of local community-based organizations that provide Pre-K and see if they have seats for our children. Then we would have to set up from the business aspect the ability to pay for the seats and allocate seats appropriately throughout the community – it would probably be done by some sort of lottery system. Dr. Pecora went on to say that it was something they are looking at but not sure it could be actualized because a lot of things must come together, and the funding is only a two-year commitment

Ms. Stark spoke about the Seaford Public Library vote. Ms. Meserole advised that in addition to the School District Budget and Trustee Election, the Seaford Public Library budget would be on this year's ballot. Mr. Kahn advised that the Library also had one seat up for election and that would also be on the ballot.

At 7:25 p.m., a motion was made by Mr. Devlin, second by Ms. Stark, to adjourn the Special Meeting and enter into Executive Session for the purpose of discussing the employment history of a particular and upon completion of discussion respecting the foregoing to return to open session.
