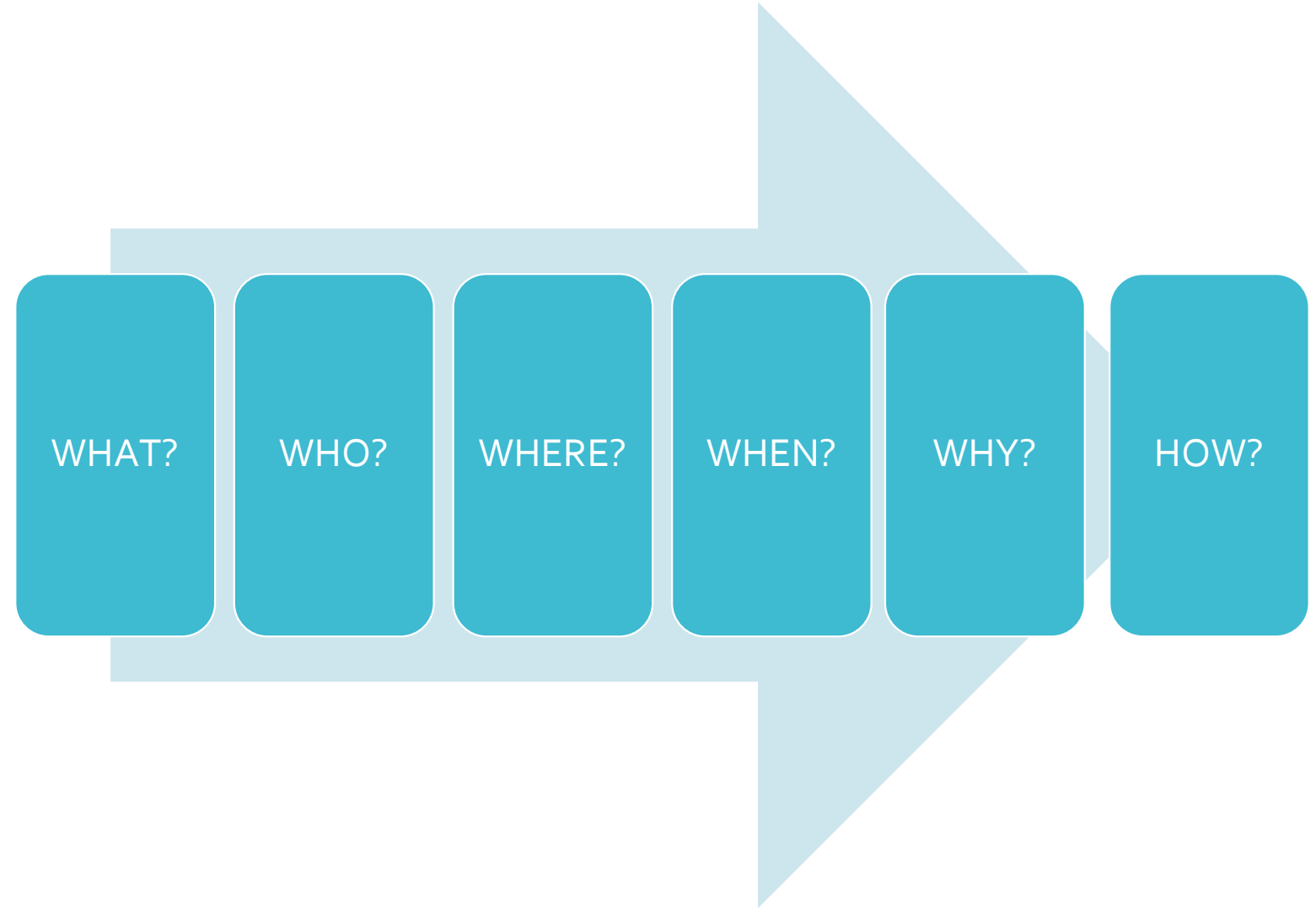

- Determine Resolution
  - Correcting Course Codes

  - Applying for Waivers

# WHY?

Why should we invest our time in this endeavor?

- As with all of your data, the number of teachers teaching outside their certification area will appear on you district's *New York State School Report Card*



# HOW?

How do we complete the task?

1. Verify with the District Data Coordinator (DDC) that recent data were loaded into Level O
2. Review SIRS-328, Staff Out of Certification Verification Report
3. SIRS-329, Staff Certification Report
4. Look up Certification in Course "Crosswalk" file
5. Compare Certification's courses to your course content.
6. Make corrections in your SIS, Level O or other action as appropriate

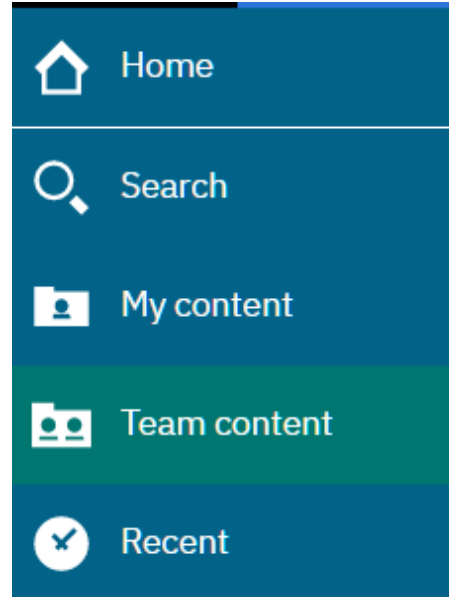

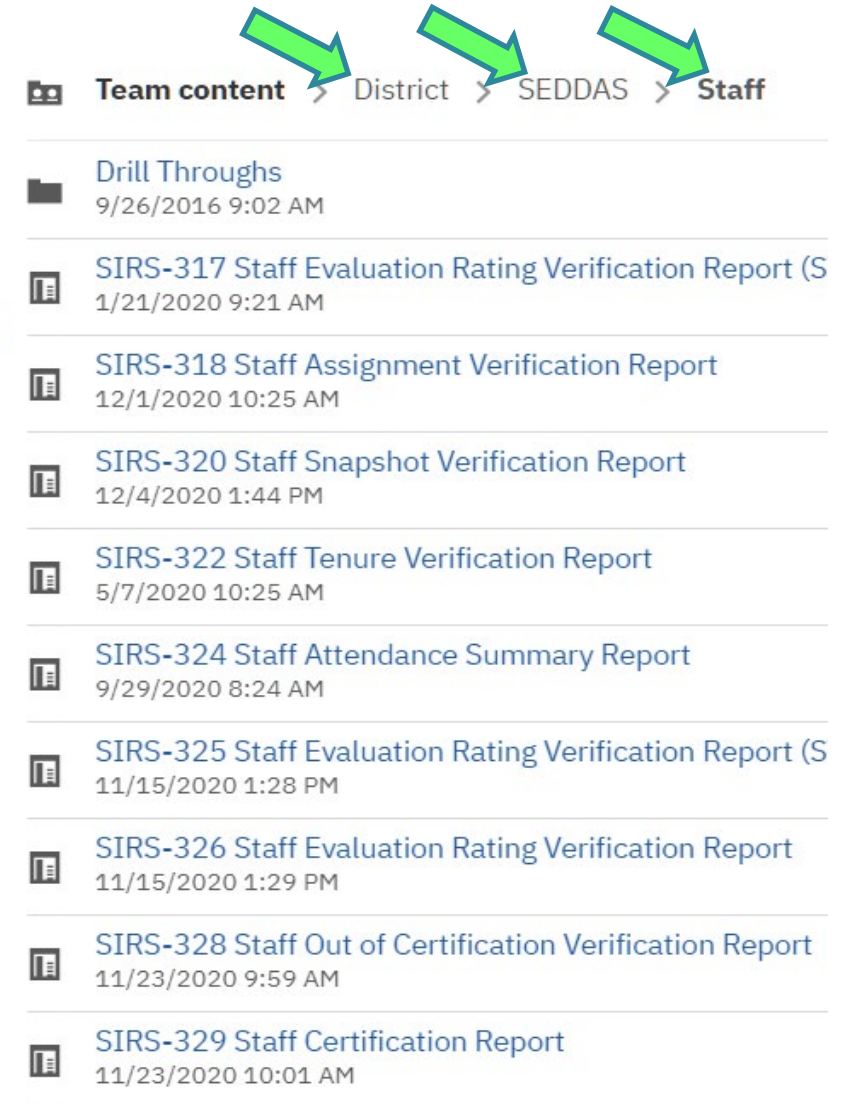

- This report can be run by entire district, by building, and by individual teacher.



**STEP 2- Verify:** In this example, the teacher is certified to teach Grades 1-6 and Grades 1-6 for SWD

When looking at Certification Area Code 3014, we verify that the teacher is NOT certified to teach the courses that were associated with this teacher in Level O. These courses are not Kindergarten.

When we look at Certification Area Code 9014, we see that the teacher IS certified to teach Kindergarten Special Class, formerly Self Contained. This was not the course that the teacher was associated with though.

NOTE: Any time a teacher is the primary special ed teacher for a course, it needs to be set to yes. If they are the only teacher, they also need the primary teacher flag set to yes.

## Step 4: Discussion

Here is where the team approach becomes very important.

### Confirm Class Being Taught Is Same as Reported

- Questions to ask/Information to confirm:
  - Is this a General Education Kindergarten class?
    - If yes, then the teacher is out of certification.
    - Is there a reason why the district has this teacher in this class?
      - If yes, go to Step 6.
  - Is this an Inclusion Kindergarten class?
    - If yes, then the teacher is out of certification.
  - Is this a Special Class Kindergarten?
    - If yes, then the teacher IS IN certification

## Step 5: Corrections

For our example, we determined upon further inquiry that the teacher is actually teaching a Special Ed Kindergarten class.

- Let's return to review the SIRS 328 report:

- First, we must communicate the changes to the DDC or person who loads data to level O.

- Next, we must correct the course alignment by deleting the old course codes and adding 99002, Special Class (SelfContained) -K-6 Elementary.
- Lastly, we must change the Special Ed Indicator, column m, to YES

Next we go to the Certification / Course Crosswalk and compare the certification codes to the out of certification course code.

In this example, the teacher is certified in certification area codes 0126, 3013, 3014, and 9014.

Filter the Crosswalk document in Column C to those certification codes.

The teacher is out of certification for course code 51045. Filter the course code, column A, to course code 51045. In this example it will not appear, therefore, this is not a valid code for any of this teacher’s certifications.

Next you must determine if the teacher is actually teaching out of certification or if you are using an incorrect code for the course.

- What is Reading (grade5)? Confirm the course content with colleagues.
  - Is this a Special Education course? AIS? Language Arts?
- Look at the courses that are in certification for this teacher. Is there another code that can be used?
- In this example, the district determined that 5<sup>th</sup> Grade Reading was Language Arts (grade 5) and changed the code in their SIS/SMS and Level O

## Step 6: Waivers

- Is there a Special Circumstance that would explain why this teacher is teaching this class?
- There could be many valid reasons.
- If the districts believes that the reason is valid, you must apply for a waiver from ESBOCES District Superintendent, using the Application for Incidental Teaching Assignment.
- The form is available on the ESBOCES Data Central website homepage.



- **If your waiver is approved, then you must share that information with the DDC so that the Incidental Teacher field can be changed to YES.**

03996- Life & Phys Sci- Supplemental  
04996- Social Sci & Hist- Supplemental

# Summing up

- You may need to go back and forth a few times between the Crosswalk and the reports to find the correct course code for teachers on the SIRS 328 report.
- The good news is that once you fix the course codes this year, you will have fewer errors in the coming years.
- Load the data **NOW** and make corrections early to avoid incorrect data appearing on your NYS Report Card.

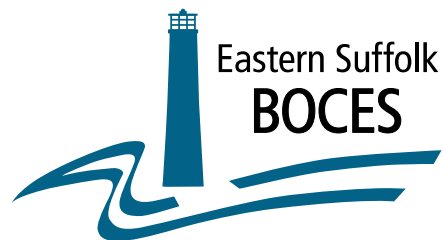
