Approved the minutes of the Revised Workshop/Regular Board Meeting held on October 19, 2020.

Approved the extended Seamless Summer Option (SSO) and Summer Food Service Program (SFSP) through June 30, 2021 (e-mail from the PDE Bureau of Budget and Fiscal Management Division of Food and Nutrition attached).

Discussion held related to the Allegheny-Clarion Valley School District Phased School Reopening Health and Safety Plan including the Athletic Return to Play Plan. (Updated the Emergency Instructional Time Template Section 520.1 with Appendix A: Sample Weekly Schedules as of 11/16/20).

Health and Safety Plan (Instructional Model) - Approved the Allegheny-Clarion Valley School District closure in grades K – 12 from November 16, 2020 through December 4, 2020. The district will transition from face-to-face learning to distance learning and will provide planned instruction during this closure.

Return to Play Plan - Approved if/when the Allegheny-Clarion Valley Area School District has to close due to COVID concerns, all athletic programs and extracurricular programs will be closed. There are no practices or contests during the closure. If/when the Allegheny-Clarion Valley Area School District is in a hybrid setting with students on campus (50%) during the school day, all athletics and extracurricular activities will be permitted to continue as scheduled. This could change on a day-to-day basis, pending guidance from the Department of Health and Pennsylvania Department of Education.
