- 3. Can you clarify the following:
 - a. page 6, third paragraph, is this for the asphalt bid?

This is a typo. It should state: qualified asphalt or paving provider.

b. Page 10, all bid forms to be completed by ink

This is a typo and will be adjusted in future bids and RFPs. Any reference to filled out in ink or Signatures in long-hand refers to printing as opposed to handwritten information or digital\image based signatures as opposed to long-hand. Any references to a wet signature require a hand written signature in blue or black ink.

c. page 87, checklist for the bid submission sheets

The bid document requirements are required for the bid opening. All other documents required will be provided once the bid award has been announced.

d. Is there an estimate for this project?

This is a CUPCCAA formal bid and the bid threshold set by CUPCCAA for formal bids is \$200,000. The District does not provide bid estimates. All
