NOW, THEREFORE, BE IT RESOLVED, by the Board of Education of the Romulus Central School District as follows:

1. The Board of Education hereby appoints Jennifer Hayden as the Superintendent of Schools of the Romulus Central School District, effective July 1, 2024.
2. The Board of Education hereby approves the proposed Employment Agreement of the Superintendent of Schools for the Romulus Central School District, for a term commencing July 1, 2024 through June 30, 2027, all terms and conditions of employment set forth in such Agreement and authorizes the President of the Board of Education to sign such Agreement on behalf of the Board.
3. This Agreement shall become effective upon execution by the Parties on July 1, 2024.
