I understand my student's failure to abide by all communicated laws, rules and policies in the Student Code of Conduct, Student handbook or any specific campus rules and regulation, shall cause the principal or designee to take disciplinary action as specific in the Code and Handbook and the request for enrollment may be revoked. The District Executive Committee or District Administrators will make the determination.

### READ - IMPORTANT INFORMATION

<b>Resident</b>	<p>Texas Penal Code, Section 37.10 Tampering with Governmental Record A person commits an offense if he:</p> <ol style="list-style-type: none"> <li>1. knowingly makes a false entry in, or false alteration of, a governmental record;</li> <li>2. makes, presents, or uses any record, document, or thing with knowledge of its falsity and with intent that it be taken as a genuine governmental record; or</li> <li>3. intentionally destroys, conceals, removes, or otherwise impairs the verity, legibility, or availability of a governmental record.</li> </ol> <p>An offense under this section is a Class C misdemeanor. (A person found by a court to be guilty may be fined up to \$500.) Education Code, Section 25.001 Admission In addition to the penalty provided by Section 37.10, Penal Code, a person who knowingly falsifies information on a form required for enrollment of a student in a school district is liable to the district if the student is not eligible for enrollment in the district but is enrolled on the basis of the false information. The person is liable, for the period during which the ineligible student is enrolled, for the greater of:</p> <ol style="list-style-type: none"> <li>1. the maximum tuition fee the district may charge under Section 25.038 of this code; or</li> <li>2. the amount the district has budgeted for each student as maintenance and operating expenses.</li> </ol> <p>(A person found guilty of falsifying information on an enrollment form may be liable for tuition for a sum in excess of \$5,000.)</p>
	I must notify FriendswoodISD within 3 days if the parent and students listed above cease to reside full time at this address.
	I understand that this child will be administratively withdrawn from FISD if it is determined that I have enrolled the child based on false information. I also understand that FISD utilizes law enforcement to verify residency. A random check to the physical Friendswood address may occur. I agree to cooperate fully with the officer or an officer of the school district verifying residency.
