



The Trigg County Schools Board of Education will accept sealed bids for used cafeteria tables and chairs. (55) Round tables are 60 inches and fold up. There are 55 black tables total and 400 mixture of red & black chairs but bid will **be per table and per chair**. Winning bidder will have the option to purchase any or all **tables & chairs** at winning bid price. If winning bidder does not wish to purchase all tables or all chairs, the next highest bidder will have the option to purchase remaining tables at the next qualified bid price. This process will continue until all tables and chairs are sold. If winning bidder does not pick tables or chairs with the above time schedule, Trigg County Schools will bill winning bidder for disposal.
