

## DeMatha Catholic High School Financial Information

### Tuition:

Tuition for the 2024-2025 academic year is **\$22,700**.

### Tuition Refund Plan:

Approximately 95% of the annual operating budget of DeMatha Catholic High School is funded through tuition. Therefore, it is important that parents and guardians meet their financial obligations to the school so that the school can meet its financial obligations to the faculty and staff as well as meet the costs of operating the school's buildings and programs. Without tuition payments, DeMatha Catholic High School will not be able to continue to educate young men. Please note tuition does not include food.

Since DeMatha relies on tuition dollars, all tuition and any additional fees paid are non-refundable unless the student is withdrawn for the 2024-2025 school year by written notice received on or before July 15, 2024. Unless the student is withdrawn by written notice received on or before July 15, 2024, tuition and fees are due for the entire 2024-2025 school year. Notice of student's withdrawal must be in writing, sent by certified mail, return receipt requested, and received by the Registrar on or before July 15, 2024. **Please note that the Enrollment Fee and Tuition Deposit described below are non-refundable regardless of withdrawal date.**

With this in mind, DeMatha requires all students to be covered by a Tuition Refund Plan (TRP) if their tuition is not paid in full by July 1, 2024. **This plan is optional for those families that pay their tuition in full by July 1, 2024, but it is strongly recommended.** The annual cost of the TRP is \$454 for the 2024-2025 academic year, and will be included on your annual tuition bill. The TRP is designed to protect your annual financial obligation under the Tuition Agreement. This program insures tuition (prepaid and due) in the event of separation from DeMatha according to terms of the policy.

### Enrollment Fee and Tuition Deposit

A **non-refundable** enrollment fee of \$450 and a **non-refundable** Tuition Deposit of \$300 are charged for all new students and are due by **March 8, 2024**

### DPO Fee:

All families must pay \$40 fee to the DeMatha Parents Organization each year. This fee will be included on your annual tuition bill. This fee is charged in lieu of fundraising by the DPO.

### Technology Fee:

All families must pay a \$150 Technology Fee. This fee will be included on your annual tuition bill.

### Tuition Payment Plans:

#### *Option 1:*

Tuition is paid in full to DeMatha by July 1, 2024

#### *Option 2:*

Tuition is paid in 10 installments beginning in July 2024 and ending in April 2025. This payment option requires parents to set up an automatic payment plan at the time of enrollment to pre-authorize their bank or credit card company to automatically transfer funds to the school on monthly payment dates. Dates selected may be the 5<sup>th</sup> of the month or the 20<sup>th</sup> of the month.

#### *Option 3:*

Tuition is paid in 4 installments in July 2024, October 2024, January 2025, and April 2025. This payment option requires parents to set up an automatic payment plan at the time of enrollment to pre-authorize their bank or credit card company to automatically transfer funds to the school. Dates selected may be the 5<sup>th</sup> of the month or the 20<sup>th</sup> of the month.
