COURSE DESCRIPTION:

This course is designed for students whose English proficiency is Emerging or Expanding and they require instruction in English foundational skills. Students at this level are challenged to increase their English skills in more contexts and learn a greater variety of vocabulary and linguistic structures, applying their growing language skills in more sophisticated ways appropriate to their age and grade level. Strategic English (ELL) is a targeted reading/language arts intervention program/course that addresses English language development while supporting access to grade-level ELA standards. Course materials/instruction is designed to provide and accelerate student language development. This course covers listening, speaking, word analysis, reading fluency, reading comprehension, writing conventions,

informational literacy, and literary response and analysis.
