- 5. Whether and to what extent the additional service unavoidably disrupts current transportation schedules
- 6. Whether other reimbursable types of transportation are available; and

**Whereas** the option of offering payment in lieu of transportation is provided in Ohio Revised Code; Therefore, be it

**Resolved** that the Solon Board of Education hereby approves the declaration that it is impractical to transport the students identified herein and offers the parents/guardians of students named in Exhibit G payment in lieu of transportation.
