## SOLON SPEECH & DEBATE TEAM WINS SECOND STRAIGHT STATE CHAMPIONSHIP

Solon's Speech & Debate team notched its second consecutive state championship this month, finishing first out of 84 schools that competed at the 2023 Ohio Speech & Debate Association State Finals. Leading the way for the Comets was Solon High School seniors Dev Ahuja, who won a third straight state championship in U.S. Extemporaneous Speaking, and Sarah Laio and Viresh Mittal, who won the state championship in Policy Debate.

Special recognition goes to Vikram Sundaram, who was named the 2023 District Student of the Year by the National Speech & Debate Association.

For this year, 52 Solon students qualified, and 27 team members placed in the multi-category state competition.

"This team is spectacular," said Dan Ceci, Solon Speech & Debate coach. "We already have 15 students qualified for nationals in June and we still have an additional qualifying event in April. This team is so supportive of one another. Many of them have been competing together since seventh grade."
