administrative discretion on behalf of this Board in the formulation of public policy, expenditure of public funds, enforcement of laws, rules and regulations of the State, and county, or cities, or of the Board, or the execution of public trusts. The retention of such services may be terminated at any time by the Board or said firm by written notice to the other, and

BE IT FURTHER RESOLVED that for such legal services, said law firms shall be paid reasonable fees as approved by the Board, and shall be reimbursed for actual out-of-pocket expenses (including but not limited to, travel, long distance telephone and duplicating expenses) incurred in rendering such legal services, from funds appropriated, or that may be appropriated, by the Board from time to time for such purpose.
