INFORMATION ITEMS

FEDERAL GRANT ROBUST PROGRAMS – INADEQUATE FUNDING

Our district receives some federal grant financial assistance based on our overall curriculum and student need. This federal funding sometimes can vary greatly from year to year. Our 16-17 school year federal grant funding has been reduced to the point our General Fund will need to pick up the additional expenses. If the General Fund did not pick up the additional expenses, our programs associated with these federal grants would be significantly harmed and not nearly as robust as they are today.

Should our federal grant funding increase in the future, the additional funds will be utilized to once again fund these positions.

IDEA Part B: We have 13 employees who are working each day on approx. 85% IDEA Part B, but we only have enough funding in 516 to pay for 68% salaries and 38% benefits

Title III LEP: We have 1 employee who is working each day on approx. 73% LEP, but we only have enough funding in 551 LEP to pay for 52% salaries and 0% benefits

Title III Immigrant Ed: We have 1 employee who is working each day on approx. 13% Immigrant Ed, but we only have enough funding in 551 LEP to pay for 0% salaries and 0% benefits

Title I: We have 3 employees who are working each day on approx. 100% Title I, but we only have enough funding in 572 to pay for 100% salaries and 33% benefits

Title I: We have an additional 3 employees who are working each day on approx. 50% Title I, but we only have enough funding in 572 to pay for 0% salaries and 0% benefits

Early Childhood: We have an 1 employee who is working each day on approx. 93% Early Childhood, but we only have enough funding in 587 to pay for 28% salaries and 0% benefits

Title II-A: We have an 1 employee who is working each day on approx. 93% Title II-A, but we only have enough funding in 590 to pay for 44% salaries and 0% benefits

SOLON RELEASES THIRD ANNUAL QUALITY PROFILE

Joining 60 other districts statewide, the Solon Schools released our third annual Quality Profile, a comprehensive community-oriented companion report to the State of Ohio School Report Cards. The Quality Profile details additional accountability indicators that more completely define a high-quality public education.

Solon's Quality Profile demonstrates the depth and breadth of the excellent educational program provided in all seven schools and reflects the values and goals outlined in the district's mission and Strategic Plan. Specifically, the Quality Profile outlines results in the following categories: Academics; Arts, Athletics & Activities; Student Leadership & Engagement; Fiscal Stewardship; Parent & Community Involvement; and Student Services.

"Our most recent Ohio School Report Card ranks Solon #1 in the state for student achievement and we are gratified to see the achievement of our students at such high levels," said Solon Superintendent Joseph Regano. "However, providing the best possible educational program extends beyond the accountability measures graded by the state. Families move to our community for the wide range of opportunities their children are able to pursue through the Solon Schools." The district is committed to ensuring academic success as well as inspiring students to follow their passions and achieve personal excellence outside the classroom and in the community.

Released by districts throughout Ohio, the Quality Profiles are supported by the Alliance for High Quality Education, an education consortium that works to improve educational opportunities for students and to advocate for member districts on educational policy and school funding in Columbus.
