## REGULAR MEETING

### TREASURER'S REPORT

The Board approved the payment of bills totaling \$34,494.59. The Board approved the final transfers and advances to close out fiscal year 2022.

The revised appropriations for the Solon City School District to provide for current operating expenses and other expenditures during fiscal year ending June 30, 2022, was approved. The temporary appropriations for the Solon City School District to provide for current operating expenses and other expenditures during fiscal year ending June 30, 2023, were approved. The Board approved the Treasurer to request and receive an advance of funds for 2023.

The Record Disposal Request Forms were approved. The items requested for disposal are in compliance with our District's Records Retention Schedule.

### SUPERINTENDENT'S REPORT

The Board approved the resolution as stated below, which permits the Board to reimburse parents whose children attend a private school for which it is impractical to transport their children.

In accordance with the Ohio Revised Code Section 3327.02 providing that Boards of Education consider all factors identified in Ohio Revised Code Section 3327.02, and determine whether or not transportation shall be provided to non-public schools for district resident children, payment in lieu of transportation shall be offered to parents of children at the rate established by the State Board of Education.

The Solon Board of Education finds it impractical to transport to the non-public schools and offers the parent(s)/guardian(s) of the students, payment in lieu of transportation.

Administrative contracts were approved for Julia Howell from August 1, 2022, to July 31, 2025, and Erin Short from August 1, 2022, to July 31, 2024.

The Board approved the administrative, director/coordinator and supervisory and confidential employee's salary schedules.
