## **TREASURER'S REPORT**

The Board approved the payment of bills totaling \$44,005. The Board approved the final transfers and advances to close out fiscal year 2021.

The revised appropriations for the Solon City School District to provide for current operating expenses and other expenditures during fiscal year ending June 30, 2021, was approved. The temporary appropriations for the Solon City School District to provide for current operating expenses and other expenditures during fiscal year ending June 30, 2022, were approved.

The Record Disposal Request Forms were approved. The items requested for disposal are in compliance with our District's Records Retention Schedule.

## SUPERINTENDENT'S REPORT

The Board approved an Amendment to the Superintendent's Contract between the Board of Education of the Solon City School District and Superintendent Fred Bolden pursuant to R.C. §§ 3319.01.

The Board held a public hearing in consideration of re-employment of employee Darlene Hillis for one year as noted in the collective bargaining agreement between the Solon Board of Education and Ohio Association of Public School Employees complying with Ohio Revised Code 3307.353. Members of the public were invited to provide input to the Board on the issue of re-employment. The Board will act on the resolution at a future meeting.

The Board rehired retired employee Thomas Pinizzotto for one year as noted in the collective bargaining agreement between the Solon Board of Education and Ohio Association of Public School Employees complying with Ohio Revised Code 3307.353.

The Board approved a resolution that the school district does not intend to provide career technical education in grades 7 and 8 for the 2021-22 school year. A copy of this resolution will be sent to the state for approval of the career pathway exemption.

The retirement of Nancy Thistlethwaite, secretary for Solon Middle School, effective November 1, 2021, was approved. The following resignations were approved: Beth Mackens, ASL teacher at Solon High School, effective August 31, 2021; Cody Coley, Assistant to the Athletic Director, effective June 19, 2021; and Stephanie Venegas, custodial for Solon High school, effective June 25, 2021.

The Board hired Suzanne Chin as assistant principal of Solon Middle School effective August 1, 2021. Joanna Innes was approved as the Solon Parent Mentor for the 2021-22 school year. This position is funded through a grant from the Ohio Department of Education and Office for Exceptional Children. Joanna replaces Anne Dellamorte who is leaving the district after four years in this position.
