REGULAR MEETING

TREASURER'S REPORT

The Board approved the payment of bills totaling \$449,075.93. The 2018-19 tax budget was approved.

SUPERINTENDENT'S REPORT

A resolution declaring it necessary to levy an additional current expense tax levy and requesting the Cuyahoga County Auditor to certify the total current tax valuation of the school district and the dollar amount of revenue that would be generated by that additional levy was approved.

This request is the first step in approving an 8.5 mill levy request in May 2018. An additional resolution will be needed in January to complete the process. If both resolutions pass, then an 8.5 mill levy will be placed on the May ballot. The uniqueness of this request is that the net total effect on taxpayers would be 6.9 mills. This increase would be 6.9 mills and is consistent with every other Solon operating levy in the last 32 years.

This is accomplished as follows:

- Before a community vote on the levy, the Board will have reduced tax obligations by 1.6 mills by reducing the amount of millage needed in the bond retirement fund by 1.6 mills.
- Phase 1, if passed in 2018 and collected beginning in 2019, would be at a rate of 1.6 mills. The net effect to taxpayers would be **no increase** since voters would be approving millage equal to the amount of capital debt retired.
- Phase 2 would also be voted on in 2018, but not collected until 2020 and beyond.

The 2018-19 Program of Studies was approved. The Board rehired retired employee Matt Hlad for one year as noted in the collective bargaining agreement between the Solon Board of Education and the Ohio Association of Public School Employees in compliance with Ohio Revised Code 3307.353.

SOLON'S CHESS PROGRAMS NOTCH STATE HONORS

Since 2000, Solon's chess programs have produced 41 Ohio state chess champions, including 18 individual champions and 23 team championships. Solon's teams continued their winning ways last month at the 2017 Ohio Grade Level State Chess Championships.
