INFORMATION ITEMS

SAY SOMETHING

The Solon Schools participated in the national Say Something awareness campaign last week to promote early reporting of suspected incidents of violence and potential threats or suicides. Resources, including videos and a fact sheet on warning signs, were sent to district stakeholders.

Research shows that at least one person is aware in advance of incidents of school violence and student suicides. Specifically, 80 percent of school shooters told someone of their intent prior to the shooting and 70 percent of people who commit suicide shared a warning or indication of their plans in advance, according to the Sandy Hook Promise organization. Sandy Hook Promise is a national non-profit dedicated to raising awareness and providing education to prevent gunrelated deaths due to crime, suicide and accidental weapon discharge.

By "Saying Something" and reporting warnings or concerns prior to an actual event, tragedy can be averted. At the end of this message you will find video links and a fact sheet to help you know what to look for and identify warning signs and potential signals and threats, particularly on social media, by people who may intend to harm themselves or others. It is critical for students or adults to "Say Something" to a trusted adult and get help if they see something that doesn't seem right or is concerning. It is always better to be safe and report a concern than to regret not saying something sooner.

For us in Solon, providing a safe and secure learning environment for students is our priority every day. Our district emergency operations plan includes many safety and security measures.

One tool we provide to students, parents and the community at large to support our safety and security efforts is the Safe School Helpline.

Students, parents and community members may use the Safe School Helpline to report threats of violence, suicide, bullying and illegal activity that could harm children or adults in our schools. By using the Safe School Helpline, students, parents and community members are able to leave a message or speak with a crisis counselor for immediate needs. The helpline is administered by an independent, outside company and reports and communications are CONFIDENTIAL and ANONYMOUS.

Safe School Helpline is easy to access – especially with the new free Safe School Helpline app available through Apple Store and Google Play. Through the app, reports can be made by texting, making an online report or calling. Texts, calls and online submissions can also always be made directly without using the Safe School Helpline app.

All messages are relayed immediately to the appropriate district staff for investigation and follow up. All information remains anonymous. The key is that safety concerns are reported as soon as possible. Anyone reporting a concern through the Helpline receives a case number that can be used later to confirm the report was received and investigated.

Students and family members are urged to contact building principals, counselors or other trusted adults at the school at any time to share concerns without using the Helpline.
