HSD Recovery Plan Initiatives

- The 2021 Amended Recovery plan outlines 62 initiatives across a variety of categories with the purpose of addressing the three guiding principles identified in the plan: academic achievement, financial management, and student stability
- As of June 2023, of the 62 initiatives, 61 (or 98.4 percent) have been completed, are completed/in progress, or are in progress
- The table below summarizes the different categories

AP04: Use academic data to inform instructional practices

- 1st Quarterly ISM
 - A key look for- G.L.E.A.M- specifically focused on (G)rade-(L)evel tasks found that 55.4% of classrooms identified had scholars working on grade-level content.
 - At least 50% of classrooms observed were using district identified materials and resources for instruction
- Professional Learning
 - Explicit Instruction- 4 sessions to date (google classroom)
 - Scaffolding Learning Through Language
 - Writing with Multilinguals Using the Teaching and Learning Cycle
 - Pathways to Proficient Reading
- Next Steps:
 - Develop/secure professional development for the appropriate use of district prescribed materials for core instruction
 - Support lesson planning for instructional staff focused on the purpose of the lesson, pacing of the lesson, preparation of materials and resources needed for the lesson, and the target/task alignment for including scaffolding support to help scholars access grade-level standards

• The 2023 Amended Recovery Plan replaced the four academic goals established in the 2021 Amended Recovery plan. The goals will be used to evaluate District progress towards improving student academic achievement. The renewed goals focus on early learning, reading proficiency and kindergarten readiness, college and career readiness, and creating systems and processes that support student success district-wide

Establish comprehensive systems and processes to improve student achievement at all grade levels, including but not limited to using data-driven decision making, implementing standardized instructional practices across the District, using a standards-aligned curriculum, and providing safe and welcoming building climates that support and promote student learning

District steps to date:

- Tier 1 Instruction- G.L.E.A.M Instruction- Instructional Support Model Learning Walks
- Professional Learning structures- Explicit Instruction, Scaffolding and Writing for Multilinguals
- Curriculum Audit- ELA, Math curriculums developed, work with STEEL standards to implement 2024/2025, *development of social studies curriculum

Use of Educator Effectiveness to ground instructional leadership



Develop an early childhood program that focuses on early literacy and fosters partnerships with community providers and organizations in order to support early learning and school readiness

- 4 Pre-K classrooms with certified staff and teacher's assistant

Key Questions to Guide Discussion

- How will the District measure progress for the academic goals?
 - How often will metrics be reviewed throughout the School year? (I.e tracking student assessments, number of students involved in career pathways, establishing systems and procedures across departments, etc.)
 - Who is responsible for ensuring progress for each goal is being tracked regularly? How will District leaders keep each other accountable?
- How is the District prepared to address key obstacles to achieving the academic goals?
- What do we want to have accomplished in Year One, Year Two, and Year Three?
- For each academic goal, what will the District commit to targeting and accomplishing by the end of the year?
