<u>Personnel Fees*</u>				
All organizations will be charged the cost of any personnel working specifically for that event or required as outlined in this Policy. Costs will be charged as follows:				
Custodians	\$55 per hour per employee			
Maintenance/Grounds	\$75 per hour per employee			
Special Technicians	\$65 per hour per employee			
Computer Technicians	\$65 per hour per employee			
Security	\$50 per hour per employee			
Food Service	\$40 per hour per employee			
Cancellation and Other Charges				
<i>Non-Occupied Fee (tiers 2-4 only):</i> Any time a building would not otherwise be occupied by the district (e.g. weekends where no custodian is ordinarily scheduled), there will be a \$50 per hour fee for use of the building (per building), in addition to personnel costs.				
<i>Cancellation/No-Show Fees:</i> For any booking, if an organization fails to show or cancels with less than seven days' notice, a fee shall be assessed equal to 50% of the booking, or for no-charge bookings, \$100 per event. Any personnel costs incurred by the district will also be charged at 100%. The School Business Administrator shall have sole authority to waive these fees for good cause in accordance with regulations he may develop.				
Transportation Rates				
*Rates are for extra-curricular or non-district use. Use of buses must be consistent with applicable NJ statutes and regulations \$50 per hour (paid drivers) \$25 per hour (unpaid drivers)				

* Overtime rates may apply. The School Business Administrator shall have sole authority to determine the number of district personnel needed. *The district reserves the right to*

require additional personnel for any event. All spaces, regardless of rental fees, may require cleaning or special fees depending on the expenditure of time from district personnel in readying or cleaning the space.

^ Concession Stands have specific rules and requirements and may require cleaning fees for all tiers depending on the nature of the use.

Tier 1: district organizations (personnel fees for fundraisers only); Randolph-affiliated parent and booster organizations.

Tier 2: Randolph governmental agencies; Randolph-affiliated non-profit and community organizations; Randolph-affiliated religious groups.

Tier 3: non-Randolph affiliated governmental agencies; non-Randolph affiliated non-profit and community organizations; non-Randolph religious groups.

Tier 4: for-profit groups and any individual or group not in tier 1 or 2.
