

Holbrook Public Schools 2024-2025 School Choice Program

Massachusetts General Laws **Chapter 76, Section 12B** was enacted in 1991 to allow parents/guardians to send their children to public schools in communities other than the one in which they reside.

School Choice Policies

Fully completed applications will be reviewed based on the number of seats allocated by grade as follows:

- **Kindergarten** (Not Offered)
- **Grade 1-8** (Not Offered)
- **Grades 9-11** *(Open until enrollment reaches 70)
- **Grade 12** (Not Offered)

School Choice Process

ONLY COMPLETED APPLICATIONS THAT ARE RECEIVED ON OR BEFORE 4:00PM ON JULY 1, 2024 WILL BE CONSIDERED. Each applicant **must** provide Bridget Baker in Central Office with the student's official final transcript as soon as possible. This document is **required** to determine the student's entrance grade. Holbrook student enrollment will be reviewed in August 2024 and at that point open seats in each grade will be determined. Once the seats have been determined the parent/guardian will be notified by phone call if the student has been accepted into the program or not. Those who have been accepted will also receive an acceptance letter in the mail. Enrollment will not start until the parent/guardian receives the acceptance letter and contacts the Holbrook Middle-High School guidance department to start the enrollment process. Selection will be free from any type of discrimination.

Yearly Application Process

Once a non-resident student has been admitted under the School Choice program, the student has the right to remain in that district until graduation from high school unless there is a lack of funding of the program. This right exists even if the school district decides that it will no longer participate in the School Choice program.

School Choice Transportation

Transportation for School Choice students is to be provided by their parents/guardians.
