

The Discipline Committee of the Rockbridge County School Board held a special meeting on Monday, November 27, 2023 at Maury River Middle School.

Present: Trustees Catie Brown, Kathy Burant, and Wendy Lovell; Randy Walters, Chief Operations Officer; Ashley Rhodenizer, Discipline Committee Liaison.

CALL TO ORDER:

Trustee Burant called the meeting to order at 5:07 p.m.

Under Section 2.2-3711.A (2) of the State Code, Trustee Brown recommended that the Board go into a **Closed Meeting** to discuss two student discipline matters. Motion was made by Trustee Brown, seconded by Trustee Lovell, and passed by 3-0 vote.

The Board entered into the **Closed Meeting** at 5:08 p.m.

The Board returned to open session at 6:35 p.m.

Trustee Burant read the following motion to Certify the Closed Meeting:

WHEREAS, the Rockbridge County School Board has convened a closed meeting on this date pursuant to an affirmative recorded vote and in accordance with the provisions of the Virginia Freedom of Information Act; and

WHEREAS, Section 2.2-3712.D of the Code of Virginia requires a certification by this School Board that such closed meeting was conducted in conformity with Virginia law;

NOW, THEREFORE, BE IT RESOLVED that the Rockbridge County School Board hereby certifies that, to the best of each member's knowledge, (i) only public business matters lawfully exempted by Virginia law were discussed in the closed meeting to which this certification applies, and (ii) only such public business matters as were identified in the motion convening the closed meeting were heard, discussed or considered.

Upon initial motion of Certification of Closed Meeting by Trustee Burant, and seconded by Trustee Lovell, the motion passed by the following roll call vote:

Upon motion by Trustee Brown, seconded by Trustee Lovell, and passed by unanimous vote, the following action was taken regarding student case number 2324-085-09 as a result of a violation of the student code of conduct.

1. Student may return to Maury River Middle School on Wednesday, November 29, 2023. Student must attend a re-entry meeting.
2. Student will be on social probation through the end of the semester, which is December 19, 2023. During this probation period, student is not allowed to be on any Rockbridge County Public Schools' property after the regular school day; nor attend any extracurricular activities on other schools' property in which Rockbridge County Public Schools is participating.

Upon motion by Trustee Brown, seconded by Trustee Lovell, and passed by unanimous vote, the following action was taken regarding student case number 2324-084-10 as a result of a violation of the student code of conduct.

1. Student may return to Rockbridge County High School on Wednesday, November 29, 2023.
2. Student will be assigned to In-School Suspension on Wednesday, November 29, 2023.
3. Student will be on social probation through the end of the third quarter, which is March 8, 2024. During this probation period, student is not allowed to be on any Rockbridge County Public Schools' property after the regular school day; nor attend any extracurricular activities on other schools' property in which Rockbridge County Public Schools is participating.
