

The Discipline Committee of the Rockbridge County School Board held a special meeting on Wednesday, March 7, 2023 at Maury River Middle School.

Present: Trustees Corey Berkstresser, Catie Brown and Neil Whitmore; Randy Walters, Chief Operations Officer; Angela Wilder, Discipline Committee Liaison.

CALL TO ORDER:

Trustee Berkstresser called the meeting to order at 4:30 p.m.

Under Section 2.2-3711.A (2) of the State Code, Trustee Berkstresser recommended that the Board go into a *Closed Meeting* to discuss one student discipline matter. Motion was made by Trustee Brown, seconded by Trustee Whitmore, and passed by 3-0 vote.

The Board entered into the *Closed Meeting* at 4:31 p.m.

The Board returned to open session at 5:52 p.m.

Trustee Brown read the following motion to Certify the Closed Meeting:

WHEREAS, the Rockbridge County School Board has convened a closed meeting on this date pursuant to an affirmative recorded vote and in accordance with the provisions of the Virginia Freedom of Information Act; and

WHEREAS, Section 2.2-3712.D of the Code of Virginia requires a certification by this School Board that such closed meeting was conducted in conformity with Virginia law;

NOW, THEREFORE, BE IT RESOLVED that the Rockbridge County School Board hereby certifies that, to the best of each member's knowledge, (i) only public business matters lawfully exempted by Virginia law were discussed in the closed meeting to which this certification applies, and (ii) only such public business matters as were identified in the motion convening the closed meeting were heard, discussed or considered.

Upon initial motion of Certification of Closed Meeting by Trustee Brown, and seconded by Trustee Whitmore, the motion passed by the following roll call vote:

Upon motion by Trustee Brown, seconded by Trustee Whitmore, and passed by unanimous vote, the following action was taken regarding student case number 2223-079-10 as a result of a violation of the student code of conduct.

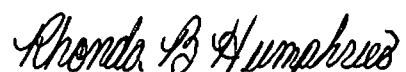
1. Student is suspended out of school through Friday, April 7, 2023.
2. Student will return to MRMS on Monday, April 10, 2023.
3. Student is required to attend a meeting with parents and the MRMS administration on Monday, April 10, 2023 at 8:30 a.m.
4. Student will be assigned to in-school suspension from Monday, April 10 through Friday, April 14, 2023.
5. Student will attend a weekly social skills session with Mr. T.J. Wills at MRMS in an effort to define and hone appropriate communication skills.
6. Student will return to regular class schedule on Monday, April 17, 2023.
7. Student will follow through with psychological counseling as indicated by parents.
8. Student will have a weekly check-in meeting with school counselor.
