

The Discipline Committee of the Rockbridge County School Board held a special meeting on Thursday, September 8, 2022 at Maury River Middle School.

Present: Trustees Corey Berkstresser, Catie Brown and Kathy Burant; Randy Walters, Chief Operations Officer; Ashley Rhodenizer, Discipline Committee Liaison.

CALL TO ORDER:

Trustee Burant called the meeting to order at 5:00 p.m.

Under Section 2.2-3711.A (2) of the State Code, Trustee Berkstresser recommended that the Board go into a ***Closed Meeting*** to discuss two student discipline matters. Motion was made by Trustee Berkstresser, seconded by Trustee Brown, and passed by 3-0 vote.

The Board entered into the ***Closed Meeting*** at 5:01 p.m.

The Board returned to open session at 6:36 p.m.

Trustee Burant read the following motion to Certify the Closed Meeting:

WHEREAS, the Rockbridge County School Board has convened a closed meeting on this date pursuant to an affirmative recorded vote and in accordance with the provisions of the Virginia Freedom of Information Act; and

WHEREAS, Section 2.2-3712.D of the Code of Virginia requires a certification by this School Board that such closed meeting was conducted in conformity with Virginia law;

NOW, THEREFORE, BE IT RESOLVED that the Rockbridge County School Board hereby certifies that, to the best of each member's knowledge, (i) only public business matters lawfully exempted by Virginia law were discussed in the closed meeting to which this certification applies, and (ii) only such public business matters as were identified in the motion convening the closed meeting were heard, discussed or considered.

Upon initial motion of Certification of Closed Meeting by Trustee Burant, and seconded by Trustee Berkstresser, the motion passed by the following roll call vote:

Upon motion by Trustee Brown, seconded by Trustee Berkstresser, and passed by unanimous vote, the following action was taken regarding student case number 2223-098-10 as a result of a violation of the student code of conduct.

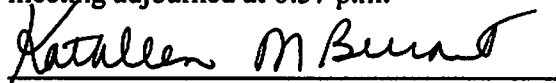
1. Student is allowed to return to Rockbridge County High School on September 22, 2022.
2. On September 22, 2022, student will be assigned to in-school detention for a single day to complete the Alcohol and Tobacco Modules and to be able to transition back into the building.
3. A referral will be made to TDT at Rockbridge County High School.
4. Student will be on Social Probation through December 31, 2022, which prohibits attendance for extracurricular activities for RCHS.

Upon motion by Trustee Brown, seconded by Trustee Berkstresser, and passed by unanimous vote, the following action was taken regarding student case number 2223-095-09 as a result of a violation of the student code of conduct.

1. Student will be on Social Probation through December 31, 2022, which prohibits attendance to extracurricular activities for Maury River Middle School.
2. On September 29, 2022, student was assigned to in-school detention for a single day to complete the Marijuana Module and to be able to transition back into the building.
3. Student will attend Maury River Middle School in the In-School Detention Room and complete schoolwork only by means of paper and pencil on the dates of September 29, 30 and October 3-7, 2022. This reflects no use or access to Chromebook or email.
4. Student will follow-up with Ms. Tori Beard, School Counselor, for a regular schedule of check-ins.
5. Student may return to Maury River Middle School for regular classes on October 10, 2022.
