2019-20 PROPOSED SCHOOL BUDGET

1.99% Spending Increase • 1.94% Tax Levy Increase

After extensive public discussion and input, the Board of Education has adopted the proposed 2019–20 school budget in the amount of \$234,418,944. This amount is a 1.99 percent increase over last year's budget. The proposed tax levy increase is 1.94 percent, which is below the tax cap limit of 4.09 percent.

"With this proposed budget, our students will continue to receive the innovative instruction that has established the Great Neck Public Schools as a premier school district on Long Island, in the state, and in the country," explains Superintendent of Schools Dr. Teresa Prendergast. "I am grateful for the support of the Board in presenting this fiscally responsible budget, which preserves our high-quality academic and extracurricular programs."

A BUDGET BASED ON NEED

Each year, the budget development process includes input from stakeholders across the District, including the United Parent Teachers Council (UPTC), building principals, teacher representatives, and district administrators. The Board of Education encourages input from residents during public budget meetings, held from March through May.

"We value the transparency of our budget process," explains Board President Barbara Berkowitz, noting that the Board has reviewed the proposed budget, line by line, during public budget meetings. "The Administration and the Board have to balance the needs of our students with our fiscal responsibility to taxpayers. We are especially mindful of the pressures on our taxpaying community."

Proposed increases to instructional staff for the 2019–20 school year reflect Great Neck's growing student enrollment. While other school districts across Long Island are experiencing a declining enrollment trend, the outstanding quality of the academic programs offered by the Great Neck Public Schools continues to attract families and new students to the District.

"The Great Neck Public Schools provide a myriad of academic programs for students of all interests and abilities. In addition, the STEAM, music, theater, sports, publications, and club programs provide opportunities for every student to find a niche in which to succeed," says Board Trustee Donna Peirez. "We are very proud to be able to offer these differentiated academic and extracurricular choices."

BUDGET HIGHLIGHTS

The proposed 2019–20 school budget will:

- Maintain all current programs at the elementary and secondary levels
- Add elementary teaching positions to safeguard class sizes, in accordance with Board guidelines, due to increased enrollment
- Add secondary teaching positions to meet student need for course offerings and electives
- Add English as a new language (ENL) and special education teaching positions to support delivery of required services
- Add one nurse to the health staff
- Add two guards to the security staff
- Expand the Universal Pre-Kindergarten (UPK) program to include classes at the John F. Kennedy School
- Initiate a drama program and a robotics program at the elementary level
- **Increase funding** for student participation in local, regional, and national competitions
- Provide ongoing professional development and training for faculty and staff

REVENUES IN 2019-20

To balance the 2019–20 budget, the District will appropriate \$2.3 million in fund balance and reserves, which are unspent funds from prior years. These funds will help to cover contractual salary increases, hikes in health-insurance premiums, and other planned expenditures. The District also allocates approximately \$4 million annually for ongoing health and safety capital projects to maintain our facilities.

Anticipated increases in revenue will also offset expenses. For example, Great Neck collects tuition from other school districts that enroll their students in programs offered here. These enrollments continue to be a significant revenue source and it is anticipated that they will yield nearly \$2.3 million in revenue in 2019–20.

SERVICES FOR NONPUBLIC SCHOOL STUDENTS

The District, in accordance with State law, allocates more than \$5 million to provide services to private and nonpublic school students, including bus transportation, textbooks, health services, special education services, school library materials, and computer software loan programs.

VALIDATION OF FISCAL PRACTICES

Great Neck is one of a select few school districts in New York State to earn an "Aaa" rating from Moody's Investors Service. This rating means that the District's financial obligations are judged by Moody's to be of the highest quality and, therefore, subject to the lowest level of credit risk. In the annual, New York State-required external audit of the school district, the certified public accounting firm of Cullen & Danowski, LLP, reports favorably on Great Neck's management of finances, emphasizing a strong financial position, wise investments, an internal control system of checks and balances, and procedures that are supported by Board policies.



VOTER REGISTRATION

If you have voted in any school or general election since 2015, you are registered to vote in the school election on Tuesday, May 21. If you have not voted since 2015 or are not registered, you may register if you are 18 years of age or older, a citizen of the United States, and have lived in the District for at least 30 days.

Registration takes place on school days from 9 AM-4 PM at the Office of the District Clerk, Phipps Administration Building, 345 Lakeville Road. You must be registered by Thursday, May 16 to vote on Tuesday, May 21. For additional details, please call the District Clerk at (516) 441-4020.

Did You Know?

Great Neck's 2018–19 school tax rate for single-family homes ranks as the fifth-lowest of all school districts in Nassau County.

NEW YORK STATE'S PROPERTY TAX CAP

Since the inception of the tax-cap legislation in 2012, Great Neck's proposed tax rate increases have been at or below the State-mandated tax levy limit. The tax levy limit for 2019–20 is 4.09 percent. Multiple factors affect the actual limit, including changes to the tax base, the rate of inflation, payments in lieu of taxes, debt payments, capital project expenditures, transportation equipment purchases, and pension increases above a certain percentage.

"We must be sensitive to the tax impact of our school district budget on our community members, who are also facing federal tax changes and Nassau County reassessments," explains Assistant Superintendent for Business John Powell. "We have to keep our outstanding educational program as affordable as possible."

ABSENTEE BALLOTS

Qualified registered voters can obtain applications for absentee ballots from the District website at www.greatneck.k12.ny.us/budget or from the Office of the District Clerk during school days from 9 AM—4 PM. Residents who are qualified voters and whose registration records have been marked "permanently disabled" by the Board of Elections will automatically receive absentee ballots. Completed absentee ballots must be received by the District Clerk no later than 5 PM on Tuesday, May 21.
