Curriculum Profile: Facing History and Ourselves (English)

<u>Course Name</u>	Facing History and Ourselves	
<u>Course Length</u>	1 year	
<u>High School Credits</u>	1	
<u>Description</u>	<p>Facing History and Ourselves is an international organization that "uses the lessons of history to challenge teachers and students to stand up to bigotry and hate." To that end, the organization provides training and curriculum guidelines for teachers. Topics of study include democracy and civic engagement, race in U.S. history, justice and human rights, antisemitism and religious intolerance, bullying and ostracism, global immigration, genocide and mass violence, and the Holocaust. In our district, the course is composed of three coordinated sections during the fall semester (English, social studies, and research) and an internship during the spring semester. Students earn 1 credit for each section, 3 credits for the course.</p>

<u>Primary texts and materials</u>	<p>Students in 11th and 12th grade English classes experience a balance of literature and informational texts in the context of instruction designed to create opportunities for learners to engage with a variety of topics, texts, and have discussions about texts that support language development and knowledge building. The focus is on using texts, printed and visual, to develop readers' concepts of how meaning is conveyed through reading and writing, and in turn their ability to make meaning of increasingly complex texts.
