# A. Superintendent's Report

Outstanding Achievement in Education Award: Ron Gimondo, principal of the John F. Kennedy School, is a recipient of the Outstanding Achievement in Education Award from St. John's University. Mr. Gimondo was presented with his award at the 12th annual Leaders in Education Awards Dinner on April 23.

<u>Coca-Cola Scholar:</u> South High senior Rachel Woo has been announced as a 2023 Coca-Cola Scholar! Rachel is one of 150 students nationwide to receive this prestigious honor. Each Scholar is awarded a \$20,000 college scholarship in recognition of their superior academics, leadership, and service to their school and community.

Writing Awards: Three students (from Lakeville, EM Baker and South Middle) have been announced as winners of the 2023 Student Poetry Contest sponsored by the Walt Whitman Birthplace Association. A North Middle seventh-grader is a winner of Nassau Reading Council's 2023 Young Authors Contest. Five middle school students (2 from North Middle and 3 from South Middle) are recipients of the National Council of Teachers of English Promising Young Writers Award. Each have been awarded First Class Distinction in this prestigious national competition.

<u>NY Thespian Festival:</u> Eleven students from South High School's -Theatre South Thespian Troupe attended the NY Thespian Festival at LIU Brooklyn this past Saturday. In addition to attending a full day of theatre workshops and presentations, several students performed for a panel of judges and were awarded top honors.

<u>Art Contest:</u> A North High student has been selected as a winner of "The Butterfly Effect" art contest, sponsored by the Town of North Hempstead's Department of Community Services.

<u>FIRST Robotics Competition:</u> Rebel Robotics attended the FIRST World Championships in Houston, Texas, where A South High student was announced as one of 10 national Dean's List Award Winners. This award recognizes student leaders who increase awareness for FIRST while achieving personal technical expertise and accomplishment, and it's one of the highest awards that an individual student can receive.

WAC Invitational Science Fair: Thirty-nine students from our district received awards at the 2023 WAC Lighting Foundation Invitational Science Fair on April 23. This annual science fair is organized by the Research Association, a consortium of teachers from 13 area schools, and sponsored by WAC Lighting. Science research projects presented by students from North High and South High earned awards in eight of the nine categories of competition.
