# **EQUAL OPPORTUNITY**

The Board of Education affirms that discrimination, in any form, to any degree, and towards any individual or group, subverts the avowed aims of a free and democratic society.

# d. <u>Policy 1530 - Smoking and the Use of Tobacco Products</u> (One Reading Only)

INFORMATION: Attached for Board of Education consideration is a revised policy: **Smoking and the Use of Tobacco Products (1530)**. The revision adds a definition of smoking and addresses a recent change to New York State Public Health Law that includes the smoking of cannabis and cannabinoid hemp in that definition. In addition, as recommended by the New York State School Boards Association (NYSSBA), the term vaping has been added to the policy's title. In accordance with *Policy 2400 Board Policy Development*, this revised policy is being submitted for a first reading and adoption.

**NOW THEREFORE, BE IT RESOLVED** that the Board of Education has hereby reviewed the revised Policy 1530 and hereby adopts same in accordance with *Policy 2400 Board Policy Development*.

# **SMOKING, VAPING AND THE USE OF TOBACCO PRODUCTS**

As part of an ongoing effort to create a healthful environment, and in compliance with New York State and Federal law and the <u>District Code of Conduct: Prohibited Student</u> <u>Conduct (Policy 5300.30) and Public Conduct on District Property (Policy 5300.70)</u>, the Great Neck Public Schools prohibits smoking (<u>the burning of a lighted cigar, cigarette</u>, <u>pipe or any other matter or substance that contains tobacco, cannabis or cannabinoid</u> <u>hemp</u>) and all other tobacco use in all District buildings, on District property, in any District vehicle and at any District sponsored function or activity.

The use of electronic cigarettes and other products containing nicotine, except for current FDA-approved smoking cessation products, are also prohibited. Electronic cigarettes or e-cigarettes, known collectively as ENDS – Electronic Nicotine Delivery Systems, are defined as electronic devices that deliver vapor that is inhaled by an individual user (including but not limited to e-pens, e-pipes, e-hookah, e-cigars, vaporizers, vapor pipes, and vape pens or any other personal vaporizing device, and shall includes any refill, cartridge or other component used in such a device.

# f. <u>Public Hearing for Adoption of 2021-2022 District-Wide School Safety</u> <u>Plan</u>

**WHEREAS**, a public hearing is required to adopt the 2021-2022 District-Wide School Safety Plan;

**WHEREAS**, New York State Regulations require public school districts to develop, review and adopt a school safety plan each year;

**WHEREAS**, District personnel have developed a plan based on a template developed by New York State and in accordance with Project SAVE and this plan outlines the District's comprehensive plans, policies and procedures to address and respond to safety, health and security issues and to implement prevention and intervention strategies in the schools;

**WHEREAS**, the safety and security of students, staff and members of the public are of paramount importance to the administrators of the Great Neck Public School District, and the District-Wide School Safety Plan will assist in successfully meeting that objective;

**WHEREAS**, students and staff will participate in exercises and drills planned by District Administration that will test our ability to respond or react to emergencies;

**WHEREAS**, the proposed revised District-Wide School Safety Plan has been made available for public comment for 30 days prior to adoption;

**NOW THEREFORE, BE IT RESOLVED**, that the Board of Education hereby opens the public hearing to allow for discussion from the public concerning the adoption of the 2021-2022 District-Wide School Safety Plan that has been developed by the Great Neck Public School District school safety team.

# g. <u>Adoption of 2021-2022 District-Wide School Safety Plan and Building-</u> <u>Level Emergency Response Plans</u>

**WHEREAS**, New York State Regulations require public school districts to develop, review and adopt a district-wide school safety plan and building-level emergency response plans each year;

**WHEREAS**, district personnel have developed such plans based on templates developed by New York State and pursuant to Project SAVE;

WHEREAS, the district-wide school safety plan outlines the District's comprehensive plans, policies and procedures to address and respond to safety, health and security issues and to implement prevention and intervention strategies in the schools, while the building-level emergency response plans detail specific steps and protocols to follow in the event of certain emergency situations, such as those requiring evacuation, sheltering, and lock down;

**WHEREAS**, the safety and security of students, staff and members of the public are of paramount importance to the administrators of the Great Neck Public School District;

**WHEREAS**, the District-developed school plans are designed to help prevent or minimize the effects of violent incidents and emergencies and to facilitate the coordination of schools and school districts with local and county resources in the event of such incidents or emergencies;

**WHEREAS**, students and staff will participate in exercises and drills planned by building and district Administration that will test our ability to respond or react to emergencies;

**WHEREAS**, the proposed revised District-Wide School Safety Plan for 2021-22 has been made available for public comment for 30 days prior to adoption, and a public hearing on the District-Wide School Safety Plan has been held in accordance with Project Save;

**NOW THEREFORE, BE IT RESOLVED**, that the Board of Education hereby adopts the 2021-22 District-Wide School Safety Plan and Building-Level Emergency Response Plans that have been developed by Great Neck Public School District personnel.

# h. Adoption of 2021-2022 District Guidance Plan

**WHEREAS**, the Guidance Plan documents the commitment of the District to prepare all students to succeed responsibly in post-secondary education and/or the workplace;

**WHEREAS**, the plan gives an overview of the requirements, goals, and support given to all K-12 students in order to ensure their successful transition to a meaningful post-secondary experience;

**NOW THEREFORE, BE IT RESOLVED**, that the Board of Education hereby adopts the Great Neck Public Schools District Guidance Plan for 2021-2022, which was prepared by a committee under Dr. Joseph Hickey's auspices, in accord with applicable regulations of the Commissioner of Education.

## i. Special Education Related Services RFP

**WHEREAS**, on January 23, 2020, the Board of Education authorized Roslyn UFSD to join with thirty-nine (39) other public school districts in Nassau County to jointly solicit proposals for Special Education Related Services for the 2020-2021 school year (and any renewal period) in accordance with the applicable provisions of General Municipal Law;

WHEREAS, proposals were sent to <u>372</u> service providers (both individuals and firms) and we received on <u>March 16, 2020</u> proposals from <u>175</u> service providers and evaluated them in accordance with the terms of an Inter-Municipal Agreement among the school districts;

**NOW THEREFORE BE IT RESOLVED**, that proposals be accepted from the responding vendors listed below for their respective services;

**BE IT FURTHER RESOLVED**, that the Board of Education hereby authorizes the District to enter into agreements with the Related Service Providers listed below for the term of July 1, 2021 through June 30, 2022, subject to the terms and conditions of agreements to be prepared by District counsel, and further authorizes the President of the Board of Education to execute the necessary documents to effectuate said agreements on behalf of the Board of Education.

# p. District-Wide Health & Safety Purchase: Distribution of Air Purifiers

[INFORMATION: In an effort to combat the spread of the COVID-19 virus and as a result of the increase in the infection rate in the surrounding community, District Administration sought multiple quotes for classroom air purifiers and investigated the efficacy of the use of various types of units in our buildings. At this time, the District Administration is recommending the purchase of 750 MA-50 Air Purifiers at a unit cost of \$250.00 and 1,500 replacement filters at a unit cost of \$50.00 for a total cost of \$272,500.00, inclusive of shipping fees of \$10,000. Additional units may be necessary should the need arise.]

**WHEREAS**, on March 11, 2020, the World Health Organization declared Coronavirus Disease 2019 ("COVID-19") a pandemic; and

**WHEREAS**, the School District's reopening plan reflects the guidance issued by the New York State Education Department and the New York State Department of Health including the District-wide implementation of certain health and safety measures designed to prevent the spread of COVID-19 among the building occupants; and

**WHEREAS**, the District has identified certain air purifiers and filters to promote air circulation in the buildings and reduce the spread of COVID-19 in the School District; and

**WHEREAS**, supplies of these items are extremely limited and lead times for delivery are long; and

**WHEREAS**, the procurement of such materials and supplies requires immediate action which cannot await competitive bidding in order to protect the health and safety of the students, staff, visitors, other building occupants, and the community at large from the spread of COVID-19.

**NOW THEREFORE, BE IT RESOLVED**, that in accordance with the provisions of General Municipal Law §103(4), the Board of Education hereby declares that the above situation constitutes an emergency and immediate procurement of such equipment, materials and supplies is necessary to protect the health and safety of its students, staff and anyone else who will occupy any of its school buildings and facilities; and

**BE IT FURTHER RESOLVED**, that the Board of Education authorizes individually the School District's Superintendent of Schools and Assistant Superintendent for Business to purchase the air purifiers and filters, as such purchase relates to COVID-19 without competitive bidding as an ordinary contingent expense and authorizes the Superintendent of Schools and Assistant Superintendent for Business and their designees individually to take all necessary and appropriate actions to take the necessary legal steps to effectuate such purchases.

WHEREAS, the Union claimed that the District's failure to pay the Employee at the enhanced rate (i.e., time and one-half in addition to their regular rate) violated Page 12, Section 34 of the Agreement; and

WHEREAS, the parties are scheduled to convene for an arbitration before Arbitrator Jay Nadelbach on August 10, 2021; and

WHEREAS, the parties now desire to resolve their differences and avoiding future litigation, the parties have had the opportunity to consult with counsel, have had all the terms and conditions of this stipulation clearly explained, and now freely consent to enter into this stipulation; and,

NOW THEREFORE, IT IS HEREBY STIPULATED AND AGREED by and between the parties as follows:

- 1. The Union will immediately withdraw with prejudice its grievance dated February 10, 2021, upon receiving notice by the District that the Board of Education has approved this settlement.
- The District shall pay members of the Union who reported to work and engaged in snow removal on February 2, 2021, compensation in the amount of 50% of the enhanced rate specified on Page 12, Section 34 of the Agreement for the hours worked on February 2, 2021.
- 3. Nothing herein shall preclude either party from raising this issue during collective bargaining between the parties.
- 4. This Stipulation of Settlement shall not be construed that the District has violated the parties' collective bargaining agreement and shall not be deemed a waiver of the Union's position regarding this grievance.
- 5. This Stipulation shall not constitute a precedent for the determination of any other dispute between the Union and the District. It is expressly understood that the arrangement

herein is predicated exclusively upon the special circumstances of this matter and shall not be construed to represent any policy or procedure of the District.

- 6. The District has consulted with counsel and the Union has consulted with a Labor Relations Specialist, and now agree to enter into this Stipulation of Settlement freely and voluntarily, without undue influence or coercion.
- 7. Except to enforce the terms of this stipulation, the parties further agree not to offer this stipulation into evidence, or introduce it for any purpose, in any forum, including, but not limited to, judicial, administrative and/or arbitration proceedings.
- 8. This Stipulation of Settlement shall be subject to the approval of the Board of Education. Should the Board not approve the agreement then this agreement becomes null and void.
- 9. This Stipulation of Settlement may be executed in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.
