c. **Policy 1525 – Intruders in the Great Neck Schools**  
**(One Reading Only)**

**INFORMATION**

Attached for Board of Education consideration is deletion of the policy: ***Intruders in the Great Neck Schools (1525)***. This policy, adopted in 1997, addresses procedures to be undertaken in the event that an unauthorized person trespasses on school property or attempts the use of school facilities. It is not required by New York State, predates adoption of the District Code of Conduct and its substance is duplicated by Policy 5300.65 *Code of Conduct: Visitors to the Schools*. Therefore, it is recommended that the policy be deleted, and in accordance with Policy 2400 *Board Policy Development* it is being submitted for one reading and possible deletion.

## **INTRUDERS IN THE GREAT NECK SCHOOLS**

In the event that an unauthorized person trespasses on school property or attempts to use school facilities including buildings, grounds, or equipment, the following procedures will be observed:

1. Any available school district employee shall ask the intruder to leave and shall immediately notify the principal or his/her designee.
2. If the intruder is unwilling to leave the school building or school property upon request, the principal or his/her designee shall summon police assistance.
3. If the intruder leaves upon request, a report of the incident shall be filed in the principal's office, and the principal, at his/her discretion, may notify the police.

d. **Policy 4750 – Promotion and Retention of Students**  
**(Second Reading)**

**INFORMATION**

Attached for Board of Education consideration is a new policy: ***Promotion and Retention of Students (4750)***. This policy is newly required and outlines District protocol for promotion and retention of students with an emphasis on early identification and intervention for students who may require additional support. It is being submitted for the second of three readings and there have been no changes since its first reading on 11/18/19. No Board action will be taken at this time.

## **PROMOTION AND RETENTION OF STUDENTS**

It is essential that each child experience both challenge and success from school activities. To this end, the District shall make every effort to place each student in the most appropriate learning level for a successful educational experience.

Academic growth, like physical growth, does not take place at the same pace or time for all individuals. Certain students may achieve mastery in a shorter period, while others need additional time. Early identification and intervention, promotion and retention are methods of meeting the needs of such children.

### **Early Identification/Intervention**

Classroom teachers are expected to make every effort, consistent with the District's implementation of Response to Intervention (RTI), to identify early those students in need of support in order to meet New York State Learning Standards. The building Principal and the parents/guardian must be notified promptly if retention is anticipated, and a special support program shall be designed for each child so identified. Such support services may include, but are not limited to, individualized small group assistance before, during or after the school day; a change in instructional approach; remedial classes; and, where appropriate, referral to a building level team or ultimately, the Committee on Special Education (CSE), for evaluation.

### **Promotion/Retention**

At the high school level, students shall be promoted providing that they can complete the requirements necessary for them to graduate with their cohort.

At the middle school and elementary school levels, students who make satisfactory progress shall be promoted unless it has been determined that they be retained as described below.

A decision to retain a middle school or elementary school student shall be arrived at by consensus from a case conference approach involving the teacher, building Principal, school psychologist, and parent/guardian. Factors to be considered include teacher recommendation; classroom achievement; standardized test scores; social and emotional development; and, for identified students, recommendations by the CSE. Standardized test scores shall not be the sole or primary factor in the decision. If a consensus cannot be reached, the decision of the building Principal shall be final.

**e. Tax Exemption – Cold War Veterans Property**

**WHEREAS**, the New York State Legislature amended the New York State Real Property Tax Law (RPTL) to authorize school districts to provide a real property tax exemption from school district taxation for Cold War veterans under RPTL§458-b; and

**WHEREAS**, state legislation was intended to provide Cold War veterans with real property tax exemptions similar to tax exemptions given to other war time veterans; and

**WHEREAS**, the Board of Education of the Great Neck Union Free School District (Board of Education) desires by this resolution to extend similar real property tax exemptions to Cold War veterans who are eligible and qualified property owners pursuant to RPTL§458-b; and

**Now, therefore BE IT RESOLVED, as follows:**

- I. The Board of Education hereby adopts the definitions of “qualified owner,” “qualified residential real property” and “Cold War veteran” as provided in the RPTL§458-b(1); and
- II. Eligible recipients shall be entitled to the exemption provided under RPTL§458-b(2)(a) to a maximum of ten percent of the assessed value of such property; provided however, that such exemption shall not exceed eight thousand dollars multiplied by the latest state equalization rate of the assessing unit, or, in the case of a special assessing unit, the latest class ratio, whichever is less; and
- III. Eligible recipients shall be entitled to the exemption provided under RPTL§458-b(2)(b) to the extent of the product of the assessed value of such property, multiplied by fifty percent of the Cold War veteran disability rating; provided, however, that such exemption shall not exceed forty thousand dollars multiplied by the latest state equalization rate for the assessing unit, or, in the case of a special assessing unit, the latest class ratio, whichever is less; and
- IV. Tenant-stockholders of eligible cooperative corporations, shall be eligible to receive such exemptions as provided in RPTL§458-b(7), and
- V. If a Cold War veteran receives an exemption under section 458 or 458-a of the New York State Real Property Tax Law, the Cold War veteran shall not be eligible to receive the exemption provided by this resolution; and
- VI. The exemption provided under paragraph II of this resolution shall be granted for a period of ten (10) years, the commencement, measurement and expiration of which shall be governed pursuant to RPTL§458-b(2)(c)(iii).
- VII. Application for the exemption shall be made by the owner, or all of the owners, of the qualified residential real property on a form prescribed by the state.
- VIII. This resolution may be repealed by the Board of Education. Any such repeal shall occur at least ninety (90) days prior to the taxable status date of the County of Nassau.

f. **Tax Exemption – Gold Star Parent of Veteran**

**Whereas**, the Board wishes to extend a real property tax exemption to the parent(s) of a child who died in the line of duty while serving in the United States armed forces during a period of war as permitted by Real Property Tax Law, section 458-a(7), **now, therefore**

**Be it resolved** that the Board of Education of the Great Neck U.F.S.D., hereby adopts the definitions of “Gold Star Parent” as provided in the Real Property Tax Law, section 458-a(7)(a), and

**Be it further resolved** that such a Gold Star Parent shall be entitled to the exemptions provided pursuant to Real Property Tax Law, section 458-a(7), to a combined maximum of twenty thousand dollars, and as limited by Real Property Tax Law, section 458-a(7)(c).

**g. Tax Exemption – Persons with Disabilities and Limited Income**

**INFORMATION**

For the last several years the Board of Education has adopted a Real Property Tax Exemption for Persons with Disabilities and Limited Income. The Board of Education first adopted this resolution in 1984 to provide Real Property Tax relief to persons with disabilities and limited income. The complete table of benefits is as follows:

**RECOMMENDATION**

It is recommended that the Board of Education approve the above table and continue to participate in the Persons with Disabilities and Limited Income Exemption Law and that the Nassau County Department of Assessment be notified of the District's participation.

## **h. Tax Exemption – Senior Citizens Real Property**

### **INFORMATION**

The New York State Legislature has extended the current level of tax exemption for Senior Citizens Real Property Taxes. The complete table of benefits is as follows:

The Board of Education, since 1970, has provided relief to certain property owners, sixty-five years of age or older.

### **RECOMMENDATION**

It is recommended that the Board of Education approve the maximum schedule of benefits permitted under the Senior Citizens Exemption Law and that the Nassau County Department of Assessment be notified of this approval.



i. **Tax Exemption – Veterans**

**Whereas**, the Board wishes to extend real property tax exemptions to eligible and qualified property owners pursuant to Real Property Tax Law, section 458-a(2), **now, therefore**

**Be it resolved** that the Board of Education of the Great Neck U.F.S.D., hereby adopts the definitions of “qualified owner,” “qualifying residential real property” and “veteran” as provided in the Real Property Tax Law, section 458-a(1)(c),(d) and (e), respectively, and

**Be it further resolved** that eligible recipients shall be entitled to the exemptions provided in Real Property Tax Law, section 458-a(2)(a), (b) and (c) to a maximum of twelve thousand dollars, eight thousand dollars and forty thousand dollars, respectively and

**\*Be it further resolved** that tenant-stockholders of eligible cooperative corporations, shall be eligible to receive such exemptions as provided in Real Property Tax Law 458-a(6), and

**\*\* Be it further resolved** that recipients of these exemptions shall be permitted to transfer, on a pro-rata basis, the exemption to another home purchased within the Great Neck U.F.S.D. as provided in Real Property Tax Law 458-a(8).

\* Extends, to residents of cooperatives, this exemption on the same basis as owners of real property

\*\* Allows recipients of this exemption who sell their home and purchase another home within the district to transfer the exemption on a prorated basis.

**j. Tax Exemption – Volunteer Firefighters and Ambulance Workers****INFORMATION**

On July 19, 2005 the New York State Legislature amended Section 466-c of the Real Property Tax Law, enabling school districts to offer a property tax exemption to volunteer firefighters and volunteer ambulance workers. The legislation includes strict guidelines for applicants to qualify for the tax assessment exemption. The exemption will be ten percent of the qualified applicant's real property assessed value. The Board of Education has, since 2005, adopted a resolution to extend this exemption to the Volunteer Firefighters and Volunteer Ambulance Workers.

**RECOMMENDATION**

It is recommended that the Board of Education continue to approve the Volunteer Firefighter and Volunteer Ambulance Worker Tax Exemption in accordance with Section 466-c of the Real Property Tax Law and that the Nassau County Department of Assessment be notified of this approval.

**k. Cyber Liability Insurance****INFORMATION**

An information security breach is one of the largest risks facing organizations today. Hacking incidents continue to compromise personal data throughout the world, with schools being specifically targeted in recent months. To help the District limit its cyber liability risk, we would like to renew for a fifth year our cyber insurance policy with Arthur J. Gallagher & Co.

The District has a separate \$1 million cyber liability insurance policy, through the New York Schools Insurance Reciprocal (NYSIR), that complements this Gallagher policy.

The Gallagher cyber liability insurance policy will cover the following:

- a. Multimedia Liability
- b. Network Security / Privacy Liability
- c. Data Recovery and Business Interruption
- d. Privacy Regulatory Defense and Penalties
- e. Crisis Management and Customer Notification
- f. Data Extortion
- g. Payment Card Industry Fines or Penalties
- h. Cyber Deception

**RECOMMENDATION**

It is recommended that the Board of Education approve and sign a one-year contract with Arthur J. Gallagher & Co. The policy will run from Jan. 11, 2020 to Jan. 11, 2021 and cost \$20,075.24, with a \$12,500 retention, and a \$2,000,000 limit of liability.

While working on the project, Gatz Sitework & Landscape Construction Inc. amended three (3) leaching basins, lowered the depth of the three drainage locations, added additional 10-foot diameter drainage rings and used clean backfill around the drainage portion of the system. This resulted in Change Order #1 for \$22,000. There was also removal of the existing soil and excavation around the drainage collars at the new drainage structure locations, resulting in Change Order #2 for a total of \$51,959.82. In addition, the Contractor provided a credit for not seal coating and crack filling 7,790 SF of existing asphalt. The Contractor milled 2" of the existing asphalt and applied a new 2" asphalt top. The cost for this additional work totaled \$19,088.26 for Change Order #3.






