TA between TCUSD and 823

1. Effective July 1, 2022-2023, the classified salary schedule (on-going) shall be increased 10 2%. Effective July 1, 2022, unit members shall receive a 2% one-time compensation on the 2021-2022 salary schedule. Should another bargaining unit receive a higher combination of off-schedule and on-going salary increase for the 23-24 year, the District shall provide an equal salary increase to CSEA 823 effective July 1, 2023.
