In SC, school librarians have a Master's degree in Library and Information Science and K-12 certification and the process of selecting materials is covered in depth in their coursework including supporting the curriculum, student interests, and community standards. School librarians then follow policies when selecting age-appropriate materials.
			Young readers need access to a variety of books from which they can learn about different perspectives, gain an understanding of others' lives, and develop critical thinking skills. 			Probably more Charleston County taxpayers know the rules for the board game "Monopoly" than know the rules for Charleston County School District Board Meetings, so thanks to Post & Courier Editorial Writer, Cindi Ross Scoppe, for giving some clarity to the contentious matter of meeting behind closed doors. SC "State law says school boards MAY meet behind closed doors to receive legal advice and discuss contracts and personnel matters. NOT that they MUST, but they MAY."
			When a Board meets behind closed doors, it is called an Executive Session, but the Board must declare its intention during the Open Meeting, must also state the "SPECIFIC" purpose, and then vote for approval to do so.
			According to the SC Press Association, sample reasons for School Board Executive Sessions include: Discussion of hiring/firing/promotion/discipline of an employee; Discussion that may lead to criminal prosecution; Discussion of contract negotiations; Discussion of security personnel and devices; Receipt of legal advice. (Public bodies CANNOT VOTE in Executive Sessions!)
			Thanks to Post & Courier writer Kenna Coe, we now know other basic rules, as given in The Freedom of Information Act (Title 30, Chapter 4 of SC's Code of Laws). A "public meeting includes a simple majority gathering of a state or local agency, school board, according to the SC Press Association." "Public notice of at least 24 hours is required, with Date, Time and Place given. Emergency Meetings must be posted as soon as details are available." (Ex: Hurricanes).
			"Meeting Agenda must be posted 24 hours in advance on a publicly accessible bulletin board at the site of the meeting and on the public body's website, if applicable." Changes to the agenda require a two-thirds vote by the Board.
			"Public Comment" is NOT REQUIRED under state law, but, if granted, that speaker cannot be interrupted or cut off just because someone disagrees with the speaker.
			A voice vote of "those in favor of" and "those opposed" is part of ROBERT' S RULES OF ORDER, which public bodies follow to provide a semblance of organization during meetings. Sample guidelines are: Allowing only the motion on the table to be discussed; Each member of the Board is permitted to speak, without interruption.
			I hope this information is helpful in determining the transparency of every School Board as it walks the delicate line of acting within its rules and guidelines.

			Coming from a military family, replete with service members from all branches, I would be remiss if I didn't acknowledge all current and veteran members as a group. In looking up a couple of military service organizations, I was not prepared for the hundreds of names and types of ministry helping servicemen/women.
			Firstly, my mind was set on former military, only to discover week-end retreats for current military families. I was further shocked at the diversity of types of ministries. Checking out a combination of my love of animals with a desire to help veterans, I discovered service dogs for handicapped vets, providing practical assistance as well as the emotional fulfillment of a pet.
			Similarly, I located home improvement accommodations that made just getting around in a house a bit easier for those who cannot stand or reach. Kitchens and baths have numerous innovations that ease the strain of cooking and bathing, making life "more normal" for incapacitated vets. Tunnel to Towers (TZT) is a familiar name, and I was pleased that they have not only paid off another 50 mortgages, but have converted a hotel into housing for the homeless, and are now working on a prototype 500 square foot home for vets and first responders.
			For other vets who may or may not have been fortunate enough to return home with limbs attached, but with minds still on the battlefield, there are mental health organizations that minister through individual counselling and group sports activities. You may be familiar with Fox's "Joey," (leg amputee) and The Combat Boots Program, with testimonials such as "Back working full-time, and helping raise my kids."
			As you become overwhelmed with donation request forms, be aware that there is apparently no evaluation organization as to what percentage of donations actually get to the vets, so you will want to choose carefully. Give to a group that accomplishes a need that hangs heavy on your heart.

		Instructional materials and policy on sexually explicit materials in CCSD	The events unfolding over the past couple months regarding the presence in some public schools within CCSD of sexually explicit books (revealed in the text and sometimes even graphics) is deeply disturbing. They argue that these books must be made available to our children, but cannot articulate a benefit that reading or viewing graphics about sex acts of all different varieties will bestow on our children, including very young children. They do not explain why the pornographic materials cannot be substituted with written materials devoid of such pornography to get the same message across. They simply decry Moms For Liberty as a "hate group", who are censoring and "banning books", skirting around the premise that pornography is not protected speech. I believe it is the Board of Trustees who must put an end to this circus. They must ensure that the existence of such obscene materials, whether in the classroom or simply available in school libraries, is first confirmed, then assessed, then removed as appropriate. Due credence should be given to obscenity laws and to the concept of "age appropriate materials", looking to commonly accepted standards for guidance, such as "R" and "X" ratings. CCSD must also ensure their own policies regarding the accessibility of such materials if for example, they were presented in another format such as film, videos, music, photographs and the like, are being
