**I. Call to Order, Invocation & Moment of Silence, Pledge of Allegiance:**

**II. Adoption of Agenda:**

L. Fyall moved with a second by E. Peterson, to adopt the agenda. The motion passed 6-0

A motion was made by E. Peterson, seconded by Fyall, to move into Executive Session. The motion passed 6-0.

**IV. Open Session Reconvened:**

**V. Vote on Executive Session Items:**

- A. A motion was made by E. Peterson, seconded by J. Bennett, to have student 5.163.21 returned to school on district probation for the remainder of the school year as well the first semester of the 2022-2023 school year. A second motion was made by J. Wilson, seconded by M. Garnett, to have student 5.163.21 sent to Liberty Hill Academy until successful completion of the program. Peterson and J. Bennett opposed / L. Fyall abstained)

- D. A motion was made by M. Garnett, seconded by L. Fyall, to have allow student 5.166.21 to return to school on district probation for the remainder of the school year. The motion passed 6-0.
- E. A motion was made by J. Bennett, seconded by J. Wilson, to allow student 5.167.21 to return to school. The motion passed 6-0.
- F. A motion was made by L. Fyall, seconded by J. Wilson, to have student 5.168.21 placed at Daniel Jenkins Academy on district probation for the remainder of the school year and the first semester of the 2022 – 2023 school year. The motion passed 6-0.
