**Policies and Procedures-** FACTS Tuition Management has been contracted to process FCA’s tuition and fee payments. FACTS provides tuition management services, allowing families to make payments through a checking or savings account or credit card (subject to a convenience fee). The enrollment process for all FCA families includes registering with FACTS Tuition Management.

Faith Christian Academy’s past due tuition policy states that accounts must be brought current within thirty days or the enrollment of the student may be discontinued. FACTS will allow families the flexibility to adjust their own payment date up to ten business days from the original due date. If necessary, special arrangements should be made with the Business Office prior to the tuition/fee due date.

**Financial Assistance-** The EITC tax credit program funds financial aid for qualifying families.
