We need a motion and a second that upon the recommendation of the Superintendent of Schools, Robert N. Julian, Jr., be appointed as Acting Principal at John F. Kennedy Middle School effective May 18, 2020 through June 30, 2020. Claire. I'll second Denise. Claire and Denise. On to question. All in favor? Aye. Opposed? Carried and so ordered.

I just want to note that Mr. Julian will still be the Principal at John F. Kennedy High School. Mrs. Galenski is there anything that you want to add?

I just to echo what you said Mr. Vohwinkel. Mr. Julian will continue in his position as High School Principal at John F. Kennedy High School and now will also assume the role of Acting Principal at John F. Kennedy Middle School effective Monday, May 18, through the end of this school year June 30, 2020. We are looking forward

to Mr. Julian assuming that acting role and we look forward to much success. Thank you Mr. Vohwinkel.

We need a motion and a second to approve the recommendation from the CSE/CPSE as submitted. Gary. Zack. Gary and Zack. On to question. All in favor? Aye. Opposed? Carried and so ordered.

We need a motion and a second to accept the following Statements of Profit and Loss: The John F. Kennedy High School Drama Group held a fall play on November 22, and November 23, 2019. The statement shows a profit of \$1,779.35; The John F. Kennedy High School Class of 2020 held a Snowball Dance on February 8, 2020. The statement shows a profit of \$1,265.99. Steph. Denise. We need an motion and a second that upon the recommendation of the Superintendent of Schools, to approve the following tenure positions: Melissa Kruszynski, being certified in Spanish 7 through 12 be granted tenure effective September 1, 2020; Timothy Miller, being certified in Math 7 through 12 be granted tenure effective September 1, 2020; Samuel Farber, being certified in Childhood Education 1 through 6 be granted tenure effective September 1, 2020; and Jamie Hooper, being certified as Library Media Specialist be granted tenure effective September 1, 2020. Zack. Gary. I heard Zack and Gary. Yes. On to question. I would just like to note that if any of these teachers are listening, the Board of Education would like to wish you congratulations. We need a motion and a second to adopt the following resolution:

Whereas the District has been approved to provide meals for children under 18 years of age; and whereas in order for New York State Education Department to complete our enrollment in the program, the Board of Education required to authorize the Cheektowaga Sloan Union Free School District to participate in the Summer Food Program; therefore be it resolved that the Board of Education of the Cheektowaga Sloan Union Free School District approves the 2020-2021 Summer Food Program as submitted. Claire motion. Second Denise. Claire and Denise. On to Question?

Will this be in two different locations?

If I might, it is going to be at three different locations this year. One at the playground within the Village of Sloan, the second will be at TR and the third one will be at Dingens. Thank you so much. We are adding another location to

hopefully feed our young students, and actually all community members under the 18 much better.

Is some kind of communication going out to the students?

Absolutely. It will be going to the whole community. You know Mary Brucz is just a wonderful food service manager and just intent on feeding everybody she can. Yes she is. Any further questions?

We need a motion and second to approve the following budget transfers: \$110,000.00 from General Fund Natural Gas to General Fund Contractual Expenses; and \$36,000.00 from General Fund Electricity to General Fund Contractual Expenses. Steph. Claire second. Stephanie and Claire. On to Question?

Could we get Wayne to elaborate a little bit on this?

Sure. We were fortunate enough to save on some utilities this year. We are separating out all expenses related to the COVID-19 pandemic. There are FEMA reimbursements potentially for some of these costs. So what we are doing is rather than just throwing them in the contractual account, we created two separate accounts for these so that we can track all the expenses related to the pandemic and potentially receive reimbursements from FEMA for some of the costs. So really it's just tracking and combining and making sure we know all the costs related to this pandemic, and there are many costs related to it.

We need a motion and a second, Be it therefore resolved the Board of Education of the Cheektowaga Sloan Union Free School District will conduct a hearing to review the budget as presented to the public for the 2020-2021 school year be held on Tuesday, June 2, 2020 at 7:00 p.m. via teleconference; and be it further resolved that the annual election take place on Tuesday, June 9, 2020 by absentee ballot to vote on the school budget, and elect two members to the Board of Education, and any other referendum or proposition to amend the budget. Gary. Zack. Gary and Zack. On to question. All in favor? Aye. Opposed? Carried and so ordered.
