Thank you.

You received the budget last time which was considered the final budget. We've been reviewing this for some time now, several months. I just wondered if there's any questions of the Board before we ask you to approve this budget. Of course there are many issues right now pending related to funding from State & sales tax etc. But whether those are answered or not this is actually the best budget we could put forward at this time fully funding current operations, and we may have to deal with whatever progresses from New York State. Any questions at all regarding the budget?

Wayne, this is Gary. Do we have enough funding for this one?

Well, right now it is funded exactly as we are given from New York State. If adjustments are made, we have been - I hate to say planning for something like this 'cause you can never plan for what is occurring right now, but we have been putting funds aside for the last six years. There are always cycles of up and down and we've been very fortunate the last few years to put reserves in place to plan for a down year. Of course nobody planned it to be quite as down as it looks right now, but yes, we are ready to deal with next year already.

Are we using a lot of our reserves?

No, in fact we're not using any reserves we're using unreserved fund balance at this point in time. We are really only using \$100,000 of debt reserve, but that's really a required use of funds 'cause those were leftover from an old project. So we're using what we're required to but we are using no reserve funds in this budget. Good, but next year is probably going to be reserves for the fact that they may go back off the 50% or a percentage next year not get as much.

Well, I kind of wish the governor wouldn't throw around percentages 'cause one day he was saying 50%, the next day 20%.

Oh, Okay.

There is a lot of issues related to funding and unfortunately we don't have any answers at this point but we have been preparing for this, not necessarily this pandemic of course but for a down year for some time now. The Superintendent has always supported let's get ready to first of all do what we need to do for students but second of all keep our community stable and solid. As you know an up and a down swing in a tax rates doesn't do anybody any good. So were planning, the

Superintendent and I have been planning for the good of our students and for our community for such a down year.

Well, I like to thank both of you for the fine job that you are doing then. I think we would all like to thank you once again for doing what you have done. Thank you so much.

Any other questions at all? Great. Thank you.

Thank you, Wayne and Andrea.

We will resume our regular agenda.

We need a motion and a second to cast a ballot for Mrs. Janet McGregor-Plarr from the Frontier Central School District as a Trustee for the Board of Cooperative Education Services for the term of July 1, 2020 through June 30, 2023. Gary motion, Steph, second. Gary and Stephanie. On to question. All in favor? Aye. Opposed? Carried and so ordered.

We need a motion at the second that shall the Cheektowaga-Sloan UFSD Board of Education be authorized to expend the sum set forth in the proposed 2020-2021 budget in the amount of \$37,136,645.00 and to levy the necessary tax. Claire motion, Claire, I'll second, Denise. Denise. On to question. All in favor? Aye. Opposed? Carried and so ordered.
