## III. Curriculum/Building Issues

## A. Elementary PSSA Presentations

Jill Berlet and Marc Dobbs, elementary principals, explained proficiency rates and cohort results. They talked about the average growth index, Lehigh County averages, and where Northwestern Lehigh elementary students exceeded the growth standards. Building goals and SMART goals (specific, maintainable, attainable, relevant, timely) were shared. They noted what paths to improvement will be utilized to raise the proficiency rates. Board members asked questions on how the data is being used to plan instruction so students continue to grow. President Snyder commented on teacher access to data and the Board's commitment to providing time for teachers to use this tool and collaborate with colleagues. Discussion followed on how this information is communicated to parents, IEP sub groups, the dip in 5<sup>th</sup> grade scores, and educational differences and comparisons to other countries.

### B. Public School PSSA Comparison to Charter and Cyber Charter Schools

Dr. Wright presented data from a regional position paper developed by superintendents from Carbon, Lehigh, Monroe, Northampton and Pike Counties. The data was used to show the impact of charter school on local school district communities. Since taxpayer money funds charter schools, the report notes how charter schools are funded, how they are held accountable and operate, and how their students perform on student achievement compared to public school students. Dr. Wright shared a graph of the five county comparison to cyber and charter schools. She noted charter/cyber schools are not held as accountable as Pennsylvania school districts are and are less impacted by mandates from PDE and DOE.

The District previously received approximately 30% reimbursements from the state for charter/cyber school costs. State reimbursement has been cut to 0%. These costs will be funded entirely by local school districts in 2011/2012. Taxpayer dollars are supporting over \$600,000 of our budget to fund charter schools in 2011/2012. The positional paper will be posted on the District website and sent to Legislators.
