Recommended Motion:

Approve the contract renewal of RFP No. FS22-22-1 with Loewy Enterprises dba Sunrise Produce Company. The extended contract period shall be effective July 1, 2024 through June 30, 2025. The estimated annual cost is four hundred fifty thousand dollars (\$450,000.00), which is subject to change based on district consumption needs.

Rationale:

On May 11, 2022, the Board of Trustees awarded RFP No. FS22-23-1 Fresh Produce, to Sunrise Produce. It is requested that the Board of Trustees extend the contract for an additional year. The companies have agreed to the one-year extension. Pursuant to Education Code Section §17596, the contracts may be renewed for an additional year based on mutual agreement, not to exceed two (2) one-year renewals. This would be the second and final renewal year.
