## **How to Work a Career Expo**

A Career Expo allows you to put yourself in front of employers who are hiring, make a good impression, and work to get an interview that could land you a JOB!

### 1. Look your best!

Three-piece suits and professional dresses are NOT required. **MEET THE BASICS TO MAKE A GOOD IMPRESSION:** 

- Make sure you have good personal hygiene: hair washed and brushed, teeth brushed, deodorant, LIGHT perfume or cologne, if any
- Clean, appropriate, not wrinkled clothes that send a positive message (appropriate logos, proper lengths if shorts or skirt, etc.)
- · Avoid hats and hoodies
- THE FIRST 60 SECONDS MATTER MAKE A GOOD IMPRESSION

## 2. Introduce yourself.

Ask some questions – this is easier to do if you have taken the time to look into the company ahead of time using the logo links to employer websites on the PARTICIPATING EMPLOYERS pages

- Approach employer tables with a smile, offer a good handshake, and introduce yourself!
- Make good eye contact, keep your head up, and keep your shoulders back

## 3. Ask questions and offer insight into your skills.

Career Expos are a two-way street. Employers want to get to know you, and you want to get to know them, to determine if you would be good matches for one another. For example, ask:

- CAN YOU PLEASE TELL ME WHAT YOUR COMPANY DOES AND THE TYPES OF JOBS YOU ARE HIRING FOR?
- WHAT DO THESE JOBS ENTAIL?
- CAN YOU TELL ME ABOUT THE WORK ENVIRONMENT, HOURS, ETC.?
- WHAT DO YOU, THE REPRESENTATIVE, LIKE THE MOST ABOUT WORKING FOR THIS COMPANY?
- MONEY SHOULD BE THE LAST THING YOU INQUIRE ABOUT, IT IS BETTER TO WAIT FOR THE EMPLOYER TO SHARE THAT INFORMATION FIRST!

# 4. Ask about what the process is to apply for a job - be prepared with the information you need to complete an application or share a resume.

The materials included in this packet include a sample application for you to complete and bring with you as a guide, as well as a sample resume from which to create your own (bring copies to share if asked). See your counselor or a teacher if you need help completing them.

## 5. Thank the employer for their time and them ask for a business card.

Saying thank you seems like common sense, but when we're nervous, it's easy to forget. A business card allows you to write a nice follow up email. Do that from your home email address as the employer will be blocked by your school email.
