On May 21, the community will vote on a proposed spending plan for the upcoming academic year. The budget has been thoughtfully developed over the past several months, and it balances continued excellence, needed support for students, and a commitment to fiscal sustainability.

First and foremost, the proposed budget preserves all existing academic, athletic, and extracurricular offerings that make Clarence unique. As importantly, the spending plan also maintains the special education, mental health, and interventionist positions that were added in recent years with federal funds. By strategically absorbing the costs into the general fund budget over a multi-year period, the budget ensures that each child will have the resources they need to experience success.

Furthermore, the spending plan also makes a continued commitment to enhancing the safety and wellbeing of students and staff. Along with safety training and site enhancements, the budget allocates funds for the addition of a third School Resource Officer (SRO) who will focus their time at the elementary level. Acting as a bridge between school and local agencies, the SRO will proactively assist as a teacher, mentor, and expert in the field of law enforcement.

To sustain the items that matter most to our school community, the spending plan prioritizes cost effectiveness, administrative efficiency, and low per pupil spending. Staying at or below the New York State Property Tax Cap (a number calculated by a state-dictated formula taking into account factors like inflation, the local growth factor, PILOT Payments, and prior year exemptions) for the 14th year in a row, the budget maintains one of the lowest estimated tax rates in Upstate New York. Despite the reality that the District will not receive an increase in foundation aid from the State this coming year, the proposed 3.68% tax levy increase remains within the Property Tax Cap and requires only a simple majority vote for approval.

Along with the budget, residents will also be asked to vote on a proposition involving the purchase of 7 vehicles that are part of the District's vehicle replacement schedule. By purchasing 3 passenger buses, 2 passenger vans, and 2 maintenance trucks, the plan keeps expenses manageable while taking full advantage of State funding that covers two-thirds of the costs. It is also important to note that the 2 passenger vans will enable the District to transport small groups of students to a variety of events at a reduced cost due to fuel and mechanical efficiencies.

While voting for the propositions, members of the community will also have the chance to elect 2 Board of Education Trustees. The unpaid members of the governance team will serve as stewards for both the District's children as well as its tax dollars by establishing organizational direction, approving policies, and adopting an annual spending plan.

# **Proposition #2 - Bus and Vehicle Purchase**

The Board of Education is asking for authorization to purchase buses and similar vehicles not to exceed \$847,262.

This proposed bus purchase proposition is part of an ongoing school bus replacement program instituted in 1988 that recommends the annual replacement of approximately 10% of our buses. This provides safer and more efficient transportation of students, and reduces maintenance costs.

The District will borrow funds for bus purchases using a five year bond anticipation note and will receive reimbursement from New York State, which is distributed over the life of the loan.

Clarence Central School District buses log about one million miles per year while transporting over 5,000 Students across the District, and to several private and parochial schools.

It is the goal of our transportation department to provide safe transportation to all our riders. This bus replacement cycle, along with our well- trained staff, and award-winning bus maintenance program work together toward this goal.

#### **Voter Verification System**

Voting inspectors will confirm a voter's eligibility by checking Erie County voter registration records. If you are eligible to vote in a school election but are not a registered voter, you may sign an affidavit attesting to your eligibility to vote.



# **Proposed Budget/Instructional Component**

The instructional component includes accounts for instruction and educational support services for the district's 4,084 students. Transportation (for 5,000 students), instructional computers, supplies, textbooks, special education services, and salaries and benefits for employees assigned to this category are reported here.

# **Proposed Budget/Administrative Component**

The administrative component of the budget provides for overall general support and management activities including the Board of Education, the superintendent's office, curriculum and staff development, personnel and business departments, and supervision and support in each of the six schools. Also included are expenses for legal services, liability and property insurance, and salaries and benefits for the administrative staff.



#### **Revenue Facts**

- The property tax cap limits the annual increase in the tax levies of local governments and school districts.

# Absentee & Early Mail Ballots

Eligible voters who cannot get to the polls on the day of the vote due to illness, or travel outside the county or individuals who would like to vote early by mail, in advance of election day may request an absentee or early mail ballot. Applications are available online or may be picked up at the District Office, 9625 Main Street, during normal business hours. Call 716-407-9102 for more information.

#### **Directions to Polling Place**

Enter the High School back parking lot from Gunnville Road near the tennis courts. Proceed to the far end of the lot and park in the designated area near the football field. Attendants will direct you to the appropriate building entrance. School officials caution that traffic may be particularly heavy from 3:30 PM when high school students are dismissed up to 8 PM.

#### **Tax Impact**

- Clarence has one of the lowest tax rates among Erie County suburban school districts.
- It is likely that the tax rate will be lower than projected if the total assessed value of the Town increases.
- The projected tax rate for 2024-25 is lower than it has been in over 20 years.

# **Strength in Support**

Whether working with students directly or connecting families with community resources, staff at the Clarence Family Support Center (FSC) say their goal is for kids to be at their best.

"While our school's primary responsibility is the academic success of our students, promoting and developing positive social and emotional habits is a crucial element of learners achieving their long-term goals," said Evan Vahratian, FSC Coordinator.

The wide-ranging responsibilities of the FSC go well beyond hosting wellness resources for students, and facilitating hundreds of referrals to community organizations. Staff from the FSC connect with students by visiting classrooms to talk about concepts like bullying and kindness, and facilitate donations like dress shoes for the District's music and arts programs. The FSC is also used by student organizations, including the High School's Culture and Community Club, as meeting space. Additionally, staff at the FSC have created new community events, working with the Town of Clarence **Conservation Council** and Clarence Community Foundation, Inc. to start Headlamp Hikes at the Clarence Nature Center. The FSC also hosts a podcast that features student voices as well as health specialists in the community.






No matter the work, Vahratian said, staff at the FSC look to build meaningful community relationships that create positive impacts. He said the partnerships that have been developed in recent years reflect the community's commitment to supporting its young people.

"When the community and the schools are working together, there's a greater likelihood of students succeeding," Vahratian said.

The annual budget vote for the fiscal year 2024-25 by the qualified voters of the Clarence Central School District, Erie County, New York, will be held at Clarence High School Gymnasium in said district on Tuesday, May 21, 2024, between the hours of 7:00am and 9:00pm, prevailing time in the Clarence High School, at which time the polls will be opened to vote by voting ballot or machine.
