Health Insurance

Deductible \$5,000 Individual / \$10,000 Family; 100% coverage after deductible

Additional Health Insurance Benefits:

- Telemedicine program
 - Available 24/7 through at no additional cost.
- Wellness Benefits
 - Annual Health Screening Participation \$25.00 contributed to HSA
 - Fitness Program Participation (10 sessions per month required) \$25.00 contributed to HSA (maximum of \$250)
 - Self Reported Fitness Activities (10 sessions per month required) \$15.00 contributed to HSA (maximum of \$125)
- HSA Contributions
 - Southeast Dubois School Corporation contributes \$500/year to employees' HSA accounts. Employees can also make voluntary contributions.

Dental & Vision Insurance:

• Paid 100% by the Corporation for Employee, Spouse and Dependents age 19 - 23 as long as the dependent is enrolled as a full time student.

Life Insurance:

Employee Cost - \$1.00/year

Employee Cost - \$23.76/year

- Spouse \$5,000 coverage
- Dependents \$2,500 coverage

Long-Term Disability Insurance:

Employee Cost - \$1.00/year

Retirement Benefits:

TRF Membership with INPRS - Southeast Dubois pays 9% of certified employees' gross pay to Indiana State Teacher Retirement.

401(a) and VEBA accounts with Security Benefit. Southeast Dubois pays 1% of teacher salary into a 401(a) and VEBA per month.

Voluntary contributions can be set up with Lincoln National, American Fidelity, and Security Benefit.

American Fidelity:

Employees are eligible for membership in the Dubois-Pike Federal Credit Union in Jasper. Payroll deductions can be elected and contributed to the Dubois-Pike Federal Credit Union.
