While a change of the calendar does not end COVID-19 or the pandemic, I enter the new year (even after the recent windstorm) with a sense of hope and with an expectation for better things to come.

As 2020 came to a close I reflected on the many difficult situations we faced as a school district, community, region, and nation throughout much of the year. In doing so, it could have been easy to lose sight of the many ways we rallied together to overcome obstacles that were in our path. While there isn't room in a newsletter to mention even a fraction of the ways we came together to support students as a community in 2020, I would like to share a few highlights.

To begin with, when the initial school closure occurred in March our staff and community rallied together to do the very best we could to ensure the basic needs of children were met and to support student learning. This is remarkable to me as we had to quickly adapt (within days) from a traditional in person learning structure to a 100% remote learning model. At the same time, our nutrition services and transportation departments immediately began providing meals through a grab and go distribution system and many staff members from throughout our system worked hard to deliver technology and printed materials to families. There was an incredible team effort last spring!

As the school year ended, our ability to send high school seniors off in the manner they deserved was in doubt. However, administrators, staff members, community members, parents, and many others worked hard to create memorable events for our Cheney High School and Three Springs High School graduates. I will always remember the drive through events, seeing the names of our seniors painted on the CHS football field and TSHS campus, the photos of seniors lining fences, and the well wishes shared across each school within our district. Although it was not a "traditional" experience for the class of 2020, many amazing memories were made and our seniors finished their high school careers knowing that this community truly cares about them and their future success.

While I was hopeful the 2020-2021 school year would begin in a "normal" manner, we know that was not the case. However, once again our staff, parents, and community rallied to create and implement a successful distance learning model for students. And, as we have phased students back into our schools for in-person learning, everyone continues to be incredibly flexible and supportive throughout each and every stage of the reopening process. Thank you!

Even though 2020 was extremely challenging for our system and community, I hope we never forget the lessons we have learned. We can overcome significant challenges when we work together, and, when we focus our collective efforts on what we can achieve, anything is possible.

In closing, I want to personally thank each and every staff member, parent, and community member for your support of Cheney Public Schools. Together we have overcome monumental challenges in the past year and together we will make 2021 the best year possible for our children and students.


