<u>May Character</u> <u>Trait</u> **COURAGE:** Displaying integrity in spite of obstacles and challenges Parents, Guardians and Community Members,

Each year I am amazed at how quickly the months fly by. It is hard to believe, but we are already in May, and the 2017-2018 school year will soon be coming to a close. Spring and the end of the school year mark the time when our students participate in annual state testing in grades 3–11. These summative assessments are designed to measure a student's progress toward meeting state academic standards in ELA and math in grades 3–10 (SBA), and in science in grades 5, 8, and 11 (WCAS).

Annual state assessments serve an important role as they provide our district with information related to the progress students are making toward meeting state standards. Having said this, state assessments are only one piece of the puzzle. To truly understand a student's strengths as well as areas that need support, we must use multiple measures such as classroom formative assessments, end of unit assessments, district benchmark assessments, and other classroom data that provides meaningful information related to a student's progress toward meeting grade level expectations.

Although I absolutely believe we should strive to improve state assessment scores within our district, and we have set goals and expectations related to state scores, I do not want to create a system that overemphasizes state tests in a way that causes our students and parents unnecessary worry or anxiety. I am also concerned when scores are used in a negative manner to penalize students, schools, and districts. Therefore, as a school district we have advocated for the delinking of high school state assessments from graduation requirements (although current graduation requirements are still linked to state assessments). In my opinion, a high school diploma should not be withheld from a senior who has met all other district graduation requirements simply because the student has not been able to pass a state-mandated test. Again, state assessments should be used to help schools and districts measure their progress and to improve—not to penalize students.

In closing, please know that while we will strive to have high test scores and a 100% graduation rate, we do not want to create a system of fear and anxiety related to state assessments. Rather, our goal is to use data and assessment to guide us in providing differentiated, quality instruction that will help every student in our system achieve at high levels.
