**VIII. Update: Five Year Forecast**

Mrs. Johnson shared an update of the five-year forecast. Property tax revenue and public utility revenue outperformed the forecast by 1.85%, but income tax under-performed by 1.55%. Forecasted expenditures are also down slightly, improving the cash balance for fiscal year end. Forecasted property tax revenues were increased due to FY24 performance and forecasted income tax revenue remained a 3% trend. Forecasted personnel services and employee benefits were reduced slightly due to recent retirements. The District will continue to monitor cash balance against the \$5,000,000 benchmark and is planning for a future operating levy in 2026 or 2027.



