The Chief Inspector of Election and District Clerk verified the voting results as follows:

PROPOSITION #1 – BUDGET ADOPTION

“Shall the Board of Education of the Marcellus Central School District be authorized to expend the sums set forth in the total amount of \$41,709,230 for the 2024-2025 school year and to levy the necessary tax therefore?”

PROPOSITION #2 – PURCHASE OF BUSES

“Shall the Board of Education (“Board”) of the Marcellus Central School District (“District”) be authorized to purchase student transportation vehicles for a combined maximum estimated expenditure of \$516,605, and to obtain the necessary funds by the levy of a tax upon the taxable property of the District, to be collected in annual installments in the years and in the amounts as the Board shall determine in accordance with Section 416 of the Education Law, and, in anticipation of such tax, to issue up to \$516,605 of obligations of the District?”

“Shall the annual appropriation for the Marcellus Free Library be increased from its current level of \$563,600 per year to \$579,445 per year (an increase of \$15,845), to be raised by the levy of a tax upon the taxable property within the Marcellus Central School District, in accordance with Section 259 of the Education Law?”


